#### New Carrollton Library Re-opening

There are two meeting rooms, a conference room, seven study rooms, and a Whisper room (quiet study). You can now park electric cars at a dual-head charging station in front of the entry. #### **Cat Story**

**Back in August**, our police department responded to a report related to the lack of activity in a neighborhood home. It turned out that the resident lived alone and passed away undetected for a matter of days, maybe weeks. The deceased owned cats. Animal Control retrieved the animals and processed them at the County shelter. A few more weeks passed. A neighbor reported seeing another cat in the window. Poor emaciated kitty weighed 3.5 pounds. My wife adopted it and consulted with our yet. Within 24 hours the cat passed away. I share this story as a re-

minder that we should all be looking out for our neighbors – community requires staying connected. I also want to praise our Animal Control officer, Chris Superville, who serves us well by providing prompt, safe and humane responses to City animal concerns. If you're not aware, please know that you can call our police department to report any animal issues within the City. I took a picture of the kitty shortly after Chris retrieved it from the deceased's house. Chris estimated that the animal had not eaten for upwards of six weeks.

#### **Cardboard Boat Contest**

One final story from the summer behind us. While the New Carrollton Pool Swim Team admits to having a mediocre season, the pool's annual Labor Day Cardboard Boat Race featured fierce competition, and loads of excitement – along with trash cans full of wet cardboard to be recycled. #### Community Tax Aid

#### "Slow Down to Get Around"

The Department of Public Works urges citizens to please be aware of the waste and recycling collection vehicles moving throughout the City. Please use caution when passing waste and recycling collection vehicles as impatient drivers usually perform unsafe passing practices.

As of October 1, 2018, it's the law in Maryland. The "Slow Down to Get Around" law protects trash and recycling collectors by requiring drivers to change lanes as they approach stopped utility vehicles, or to slow to a "reasonable and prudent speed" when they drive past. This law previously applied to tow trucks as well as law enforcement and emergency response vehicles. It is now expanded to include transportation, service, and utility vehicles including trash and recycling trucks.

# Municipal Center Renovation – Council Direction to the Administration to Proceed with City Municipal Center Renovations

**Motion:** Ms. Robbins moved that the Council direct the Administration to proceed with the renovation of the City's Municipal Center to include the following: (1) Renovation of the Council Chambers: The 'new" Council Chambers will be located in the current Legislative Chamber and that space will serve both for Workshops and Legislative Session; (2) Expansion of the Council Chambers: The renovated chambers described above will potentially be expanded in size by moving the north wall into the main hallway to create an additional 150sf of meeting space and/or by relocating the restrooms and TV studio from the current room and building a new exterior wall to enclose the alcove to create an additional 240sf of meeting space, based on subsequent Council approval; (3) Reuse of the Workshop Room: The workshop room will be converted into office space for Admin staff, specifically HR, and potentially house the new TV studio. The rear of the building will be used for storage and other overflow space; (4) Multipurpose Room, East End: The east end of the multipurpose room that houses the stage will remain unchanged and will not be included in this phase of the renovations. Should the Council choose to investigate the potential use of the stage that would be a separate project; (5) Multipurpose Room, West End: The current rear entrance to the MPR will be relocated and the room "squared off" in the lobby to make room for new public restrooms, as planned, a new ladies and men's room with three facilities in each. The kitchen will continue to serve the County meals program; (6) Addition of a New Family Bathroom: The current ladies room will be converted into a family bathroom with handicap/ADA access; (7) Addition of a New NCPD Locker Room: The current public men's room will be converted into a locker room for the NCPD including showers; (8) Relocation NCPD Security Door: The current NCPD security door will be moved to the other side of the Chief's door/men's room door thereby putting the Chief's office and locker room inside the NCPD secure space. - Robbins/Nembhard (Vote: 5-0-0)





#### **Smoke Detectors Save Lives**

The majority of fatal home fires happen at night, when people are asleep.

Contrary to popular belief, the smell of smoke may not wake a sleeping person. The poisonous gases and smoke produced by a fire can numb the senses and put you into a deeper sleep.

Inexpensive household smoke detectors sound an alarm, alerting you to a fire. By giving you time to

escape, smoke detectors cut your risk of dying in a home fire nearly in half.

**Is One Smoke Detector Enough?:** Every home should have a smoke detector outside of every sleeping area and on every level of the home, including the basement.

Fire and building codes also require a smoke detector in every bedroom for new construction. On floors without bedrooms, detectors should be installed in or near living areas, such as dens, living rooms, or family rooms.

**Mount Detectors Installation:** Because smoke rises, Wall mounted units should be installed so that the top of the detector is 4 to 12 inches from the ceiling. A ceiling mounted detector should be installed at least four inches from the nearest wall. In a room with a pitched ceiling, mount the detector at or near the ceilings highest point.

In stairways with no doors at the top or bottom, position detectors anywhere in the path of smoke moving up the stairs. But always position smoke detectors at the bottom of closed stairways, such as those leading to the basement, because dead air trapped near the door at the top of the stairway could prevent smoke from reaching a detector located at the top. Don't install a smoke detector too near a window, door, or forced air register where drafts could interfere with the detectors operation.

#### Maintenance: ONLY A FUNCTIONING smoke detector can protect you.

Never disable a smoke detector by "borrowing" its battery for another use.

Following the manufacturer's instructions, test all smoke detectors monthly and install new batteries at least once a year. A good reminder is when you change your clocks for daylight savings time, change your smoke detector batteries.

Clean your smoke detectors using a vacuum cleaner without removing the detectors cover.

Never paint a smoke detector.

- Do not give sensitive or personal information to anyone unless you are sure they are who
  they claim to be
- Do not download files sent to you by strangers or click on hyperlinks from people you do not know
- Update your virus protection software regularly
- Be cautious of the information you share on social media
- Do not allow others access to your email account
- Change your password at least annually
- Never give your password to anyone

#### **Tips for Avoiding Credit Card Fraud!**

- Shred anything with your card number on it
- Shred old credit cards when they expire or are replaced
- Avoid giving out your card information
- Report lost or stolen cards immediately
- Check gas stations and ATMs for credit card skimmers
- Do not give out your credit card number online unless you are sure the site is secure and reputable
- Be cautious when dealing with individuals/companies outside the United States
- Keep a list of all your credit cards account information in a secured location
- Check your credit card statements carefully for illegal charges and or identity theft

Keep a list of all your credit cards and account information along with the card issuer's contact information. If anything looks suspicious or you lose your credit card(s), contact the card issuer immediately to avoid illegal charges and/or identity theft.
