We made it through winter and spring has overtaken the City. The Department of Public Works has been hard at work planting flowers and trees around the City and the results are breathtaking. If you have not yet, swung by the Municipal Center to check out the new garden by our sign and flowers around the flag pole. #### New Carrollton Green Team Community Clean Up

The New Carrollton Green Team held their first community cleanup day. The cleanup was held on Saturday, April 27<sup>th</sup> and focused on Riverdale Road from the New Carrollton Public Library to Route 450. This is the first of many efforts to beautify and "green up" the City of New Carrollton. Special thanks to Karen Ruff, Assistant City Administrative Officer, and the City's Police department for their efforts in making this clean up happen.

#### Going Green: New Electric Vehicles on the Way

As noted in the last newsletter, we are adding electric vehicles to our fleet beginning with two cars for the Code Enforcement Department. This week we had a visit from the electrical contractor who will be installing the charging stations. We have also placed our order for our first electric vehicle.



#### **New Staff**

We are pleased to welcome two new staff members to the City of New Carrollton. Carlos Benson is our new evening custodian and Barry Wade has joined the Code Enforcement Department as a Code Enforcement Officer. The City held three Council Workshop Meetings to review the proposed FY2020 operating budget. The budget presented is a balanced budget and will allow the City to continue to provide the high level of service and functions to our residents that you have become accustomed to receiving.

It was a long, cold, wet and hectic winter and spring had a colder than normal start. Soon summer will bring many of us out doors to enjoy the seasonal activities of warmer days. I sent in my membership dues to the New Carrollton Recreation Club and plan to be a regular at the pool this summer. I purchased former Mayor Hanko's garden spot in the Community Garden and will be brushing up on whatever gardening skills I have used over the years. My bicycle has been taken out of winter storage, and I put the battery back in the Harley. Looking forward to the summer.

Here are some highlights of things from our community life and City Hall happenings.



Footbridge on Carrollton Parkway near Quentin St.

This little foot bridge has been relied on by residents for decades. The County closed the bridge about a

year ago after an inspection deemed the structure unsafe. I, personally, didn't agree with that conclusion and asked for a re-inspection. The County obliged and agreed with me. The City was given permission to do repairs to the floor/ decking section of the bridge and re-open it for pedestrians. All of this took place in February/March and the repairs were not completed in time for my submission to the newsletter. But if all goes well, that bridge should be open for traffic when you receive this newsletter. It's been proposed that we name the bridge after Peggy Kwik. Peggy lives on Carrollton Parkway and serves as a substitute teacher at Carrollton Elementary on a regular basis. The bridge cuts her "commute" time by some 10 minutes, and Peggy has been one of the most vocal advocates for getting County action on the project. not sure we'll be naming the bridge, but thanks, Peggy, for pushing for action on the bridge.

#### Weinbach Park Cleanup

Reportedly, the fallen tree in Weinbach Park came down around Thanksgiving 2018. And yes, the tree took some wires down with it from the nearby Pepco poles. One might think that cleaning up such storm damage could be done within days, but months passed. The downed wire sank into the ground and grass began to grow on top of sections. The tree was trimmed away from the sidewalk, but the bulk of the storm damage remained an eyesore for most of the winter.

After enough complaints from residents, I decided we needed to take some action. Even though the property belongs to M-NCCPC, I took a little action personally got out my chain saw and removed about a third of the tree in a few hours. I called Pepco to have the line removed from the ground; and it was removed within 48 hours. The area looks much better and, as of this writing, we're still waiting on M-NCPPC to remove what remains of the two fallen trees. At least the sidewalk is clear, the downed wire is gone, and the majority of the park area is free of any debris from the incident.

Thanks for both your patience while the City worked on this, and for bringing the matter to my attention in spite of the property belonging to M-NCPPC, the area is in the heart of residential dwellings and the unsightly storm damage should not have been left unattended for months. My apologies for not cleaning this up sooner. And many thanks to a number of residents who came over to help me clear away debris and logs as I cut the downed tree with my chain saw. It became a community effort, and it's exciting to see so many residents taking pride in how our community looks.

#### **Green Team**

The City's Green Team has been meeting monthly. Its first foray into the community was the April 27, 2019, cleanup of Riverdale Road from Route 450 to the New Carrollton Library. Thanks to all the volunteers. Look for more Green Team appearances in the community. The Green Team has an energetic mission statement and a challenging agenda for 2019 and thereafter. I'm pleased to have this group working with the administration.

I'm sad to report that long-time resident, Joan Jordan, passed away on March 19. Joan had left the City of New Carrollton in recent years for health reasons and moved into Rider Wood. Our condolences to Joan's friends and family. Joan was a regular at our Police Foundation Saturday meetings. She will be missed by many.

#### **Mayor's Weekly Email**

The City offers a number of ways to keep current on City events – TV, bi-monthly printed newsletter, Facebook, etc. I send a weekly email on the weekends to summarize weekly happenings here at City Hall. Email or call me if you'd like to be added to the distribution list.



#### **University of Maryland Projects**

The University of Maryland working on three major projects for the City. The biggest is restoration of the storm water creek in the center of Carrollton Parkway. The students, and staff, are considering ways to minimize erosion (sections of Carrollton Parkway are at risk of erosion underneath the surfaces), control the flow of storm water, reintroduce various forms of wildlife, and replace the non-native invasive plants with more attractive native plantings. The students' report will help us coordinate with a number of grant sources and contractors to upgrade our storm water channel.

Another Maryland team is reviewing our City's recycling program. The team is reviewing the most cost efficient ways to conduct our recycling, and evaluating the best environmentally friendly alternatives.

And yet a third team is studying our Police Department data to determine if areas with heavier uses of police resources should be funded by special taxing districts.

I'm excited about our partnership with the University, and look forward to seeing their research products and undertaking recommended projects.



#### **New Carrollton Runners Report**

Congrats to John Ramsey who set a personal best time in the College Park 5K Parkrun in March! Go John! New Carrollton sends a crew to this 5K every Saturday morning: John Ramsey, David Heintzelman, Alyssa Heintzelman, Cotter Rosenberg (my son), and me in the Parkrun 5K. All are welcome. Parkrun in every Saturday morning at 9:00 a.m. along the Paint Branch Trail. Walkers, runners and joggers all welcome. In fact, a few months ago we had a centurion celebrating his 100th birthday by completing the Parkrun 5K with us. Free to enter. #### State of Maryland Department of Agriculture Mosquito Control Program

The City of New Carrollton will participate in the State of Maryland Mosquito Control Program. The program begins Wednesday, May 29, 2019 and runs through Tuesday, September 17, 2019. Property owners are encouraged to remove any unnecessary water holding containers because they become breeding grounds for mosquitos.

The State's has a threshold for mosquito spraying. This influences the amount of insecticide sprayed in a specific area. Spraying for adult mosquitoes will be based on results from standardized surveillance methods and complaints.



Residents may see mosquito traps placed throughout the City with a blinking light on public property. These traps are used for threshold testing. Complaints or Questions regarding the program can be addressed to State of Maryland Department of Agriculture at 301-422-5080. La Ciudad de New Carrollton participa en el programa de Control de Mosquitos del Departmento de Agricultura Estado de Maryland. El programa comiensa el Miercoles, 29 de Mayo, 2019 y termina el Martes, 7 de Septiembre, 2019. Se recomienda a los dueños de propiedades que retiren contenedores de agua innecesarios, ya que se convierten en lugares de reproducción para los mosquitos.

El Estado tiene un umbral para la fumigación de mosquitos, la cual determina la cantidad de insecticida rociado en un área específica. La fumigación de mosquitos adultos se basará en los resultados de los métodos de vigilancia estandarizados y quejas.

Los residentes pueden ver trampas para mosquitos colocadas en toda la ciudad con una luz parpadeante en las propiedades públicas. Estas trampas se utilizan para pruebas de umbral. Las personas que residen en una comunidad que participa en el programa de Control de Mosquitos que desean que sus propiedades sean excluidas de las aplicaciones de pesticidas para el control de mosquitos (UL pueden solicitar una exención.

#### RECYCLE, YARD WASTE, BULK PICK UP

**Recycle:** Effective May 2, 2019, the City of New Carrollton's Public Works Department will be taking over the recycling program. Collection days will not be affected by this change. All recyclable items are to be placed in the same container. Recyclables are collected without the need to sort or separate. Equipment at the Materials Recycling Facility sorts the materials.

Acceptable Items Glass: food and beverage containers

Acceptable Items Metals: empty aerosol cans, aluminum, bimetal, ferrous, and steel food and beverage containers, aluminum foil and coat hangers.

Acceptable Items Mixed Paper/Corrugated Cardboard: all paper, aseptic/gable-top milk and juice cartons, catalogs, flattened corrugated cardboard (boxes), frozen food packaging, hard and soft covered books, craft paper bags and wrapping paper, magazines, newspapers with inserts and paper board (cereal and cracker boxes) and telephone books.

**Acceptable Items Plastics:** drinking cups/glasses, flower pots, narrow-neck containers with code identification numbers 1 through 7, wide-mouth containers such as peanut butter, yogurt, cottage cheese, sour cream, mayonnaise and whipped topping; margarine/butter tubs; prescription bottles and coat hangers.

Remember to rinse all food and beverage containers and to recap or place the lids in the recycling cart/bin.

#### **Non-Acceptable Recycling Items:**

**Unacceptable Items:** auto parts, broken glass dishes, electronics, hazardous materials, light bulbs, medical waste, mirrors, motor oil containers, packing foam and peanuts, plastic bags, plastic utensils and windowpanes.

YARD WASTE: Effective April 29, 2019, all bagged yard waste will be picked up on Mondays and Tuesdays. Bagged yard waste includes grass, leaves, small shrubs, brush, branches and limbs (less than 5 feet in length and 4 inches in diameter; can be tied up in bundles) New pick-up days will go as follows:

<u>OLD PICK-UP DAY</u>: THURSDAY & FRIDAY <u>NEW PICK-UP DAY</u>: MONDAY & TUESDAY



BULK PICKUP REMINDER: Effective February 1, 2019, Prince George's County enforced the mattress/box spring plastic cover ordinance. Residents requesting curbside collection of bulky items will be required to completely cover mattresses and box springs in a no vent protective plastic covering. Plastic no vent mattress covers are available at many local retail stores and will soon be available for purchase at the Public Works Department for a nominal fee. If you plan on renting out your home or condo in the City of New Carrollton, there are some things you need to know before renting your property.

Here are step by step instructions on how to obtain a rental license.

#### **City Code Chapter 89: Rental Property**

The purpose of this chapter is to protect the health, safety and welfare of the general public by:

Establishing minimum standards in accordance with the Prince George's County Housing Code and applicable City ordinances regarding basic equipment and facilities for light, ventilation, space heating and sanitation; structural soundness for safety from fire; for single-family rental dwellings.

Establishing the responsibilities of the owners and occupants of single-family rental units/dwellings. Providing for administration, enforcement and penalties.



It is highly recommended that you do not rent until you have completed all of the steps below. This is for your protection as well as the tenant. Rental license and fee are due annually.

#### THINGS TO DO BEFORE YOU RENT YOUR PROPERTY:

  - 2<sup>nd</sup> \$125
  - 3<sup>rd</sup> & each successive missed appointments: \$200
- **6:** An Inspector will conduct the inspection, if no violations are found you will be issued your rental license certificate. If violations are identified, you will receive a notice of violation at which time you will be allowed 15 to 30 days to complete all repairs. A re-inspection will than take place. If all violation have been corrected you will be issued your rental license certificate within 2 to 3 weeks. If the entire process is not complete within 60 days your license will be revoked.

#### Informational Announcement: Trash Container Lid Requirement Residents of the City of New Carrollton:

**Chapter 63:** Recycling and Refuse of the City of New Carrollton Code that governs the storing of trash on residential properties and requires that all trash containers have a secure fitting lid. Specifically:

63-2 Requirements relating to refuse collection containers for standard City service.

A. Single-family and household refuse must be placed in watertight, heavy plastic or metal containers that do not exceed thirty-five (35) gallons in capacity and are equipped with tight-fitting covers, which covers shall remain on the containers at all times. Garbage shall be placed in plastic bags prior to being placed in containers. The containers shall be kept in a sanitary condition.

It is very important for the health and safety of not only your residence, but also those around you, that you properly secure your refuse. Garbage containers without proper covers, or garbage in the open, attracts rodents and other scavenger animals which can carry disease and/or be dangerous to residents.

Per Chapter 1, Article IV, Section 1.21 – General Penalties: Any person found guilty of violating a provision of this Code shall be subject to a minimum fine of fifty dollars (\$50.00) and a maximum fine of one thousand dollars (\$1,000) for repeated offenses.

Please also ensure that you have enough garbage containers with secure lids for the residence. If you are unable to fully seal the lid of your trash container(s), or have to put bags on the ground, we recommend that you get another trash container.

This Information Alert is intended to serve as notice to all residents of New Carrollton that since September 1, 2017, our Code Enforcement Officers have enforced this code provision to provide proper fitting tops for your refuse container (s). You are advised that failure to do so be a violation of the Code and will result in the minimum fine of \$50. Each subsequent re-inspection and failure will result in additional fines.

**Capitulo 63:** Reciclage y Basura de la Ciudad de New Carrollton Código que gobierna el almacenamiento de basura en zona o propiedades residenciales, requiere que todos los contenedores de basura se mantengan cerrados con tapas en todo momento . Especificamente:

63-2 Requisitos relacionado con el servicio de basura estandard; recipientes de basura,.

**A.** Las basuras de residencias unifamiliares y domésticas deben colocarse en recipientes de plástico o metal o recipientes de plástico pesado no debe exceder treinta y cinco (35) galones en capacidad y debe estar equipado y cerrar correctamente con tapas las cuales deben permanecer cerradas con tapa en todo momento. La basura debe colocarse en bolsas de plástico antes de ser colocadas en contenedores. Los contenedores de basura deberán mantenerse en un estado sanitario.

Es muy importante para el bien estar y la salud de los residents y personas a su alrededor. Los contenedores de basura sin cubiertas adecuadas, o basura al aire libre, atrae ratas y otros animales que pueden portar enfermedades y / o ser peligrosos para la salud de las personas.

Capitulo 1, Articulo IV, Seccion 1.21 – Sanciones: Cualquier persona encontrada culpable de violar una disposición de este debera ser sujeto a una multa minima de cincuenta dolares (\$50.00) y o una multa maxima de mil dolares (\$1,000) por ofensas repetidas.

Favor asegúrese de tener suficiente contenedores de basura con tapas en su propiedad. Si no puede sellar completamente la tapa de su (s) contenedor (es) de basura, o tiene que poner bolsas en el suelo, le recomendamos que obtenga otro contenedor de basura.

Esta Alerta de Información tiene la intención de notificar a todos los residentes de New Carrollton que **desde el 1ro de Septiembre del 2017** nuestros inspectores del departamento de Código an comenzado a hacer cumplir esta provisión de código para asegurarse que todas las propiedades esten usando tapas apropiadas para su contenedor de basura.
