As a committed community leader, I continue to find food resources to ensure that the community has food. Since June 2020, in collaboration with The Faith Based Collaborative Outreach Group and many other organizations, the City has provided food, vegetable boxes, diapers and other items needed to people in need.

In September and October 2020 County Executive Angela D. Alsobrooks and the City of New Carrollton distributed boxes containing 32 pounds of produce, dairy goods, eggs or meat and 1 gal of 2% milk provided by Unites States Department of Agriculture Farmers to Families. In just the month of October, we distributed 75,000 pounds of food. Thanks to County Executive Angela D. Alsobrooks for her continued efforts to en-

sure that the County's food insecurities are being met. Thank you to the United States Department of Agriculture for your generosity. And a huge thank you to our City staff and the volunteers who constantly take time to help feed the community.

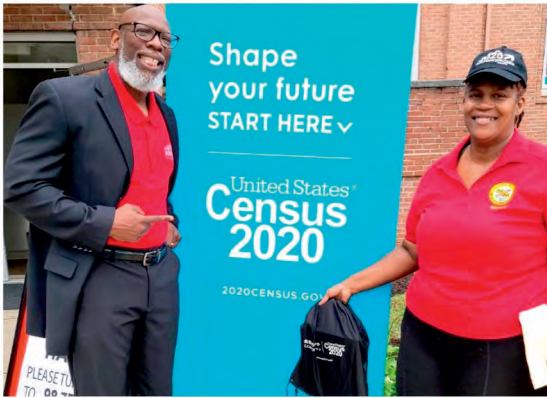

### 2020 Census



Throughout September and October volunteers, Councilmembers, City staff, community leaders and Myra & Pastor Everett Pope worked hard to promote the importance of participating in the 2020 Census. Thanks to everyone's efforts, the City had a self response rate of 68.4%. The National response rate was 67%, while the State was 71.2% and the County was 70%.

A huge thank you to everyone who helped promote and a big thank you to the residents for registering for the 2020 Census.

### EV Charging Stations at Beckett Field



The City has worked with PEPCO to install electric vehicle (EV) charging stations in the parking lot of Beckett Field. These chargers are owned and operated by PEPCO and are open to the public for their use. Users will need a PEPCO app to activate the charging station and pay for the charge. Although the charging stations were installed in early 2020, due to COVID-19 pandemic, the City was not able to have a ribbon cutting ceremony until October 6, 2020. ### Pepco Urges residents to Act Now to Establish Payment Arrangements, Secure Energy Assistance

Pepco is urging customers who may have been financially impacted by the COVID-19 pandemic to contact the company now to establish payment arrangements and get connected to customer assistance programs that can help get their accounts up to date. Pepco recognizes the financial challenges some customers are facing as a result of the pandemic and will continue its practice of working with each customer individually to help with the continuation of their electric service. Service disconnections, which were suspended in March, are always a last resort and many times, can be avoided if customers contact us to establish payment arrangement and to discuss additional options.

Pepco has expanded billing and payment options to include eliminating down payment/security deposit requirements, extending payment periods for balances and connecting more customers with energy assistance funds. During this time, Pepco has also been reaching out continually to customers who have fallen behind on their payments, as well as customers who may be eligible for energy assistance, through phone calls, letters, emails, social media, and targeted advertising.

## Highlights from the Administration

**Greetings from Administration! Below are some items the Administration Department has worked on this Fall:**

**Coronavirus Relief Fund Agreement with Prince George's County:** On October 15, the City received approval notification from Prince George's County. The Revised Plan provides \$300,000 for an emergency assistance program to New Carrollton residents to help with utility shutoff notices, eviction notices, emergency shelter, and other emergency necessities. Information about this program will be published on the City's website and social media. The COVID Relief bags that are part of the Spending Plan were distributed the week of October 26 from the Municipal Center. Each bag contained hand sanitizer, masks and either a \$100 gift card for use at the New Carrollton Shoppers, New Grand Mart or Foodway or a \$100 Costco gift card. Recipients will be required to provide proof of residency in the City of New Carrollton. There will be one bag per address. The City has an additional 1,000 One Hundred Dollar (\$100.00) gift cards to distribute at a later date.

**Resurfacing of the Municipal Center Parking Lot:** The rear parking lot and side driveways of the Municipal Center were paved October 20 and 21, 2020.

**Boiler at the Municipal Center:** The boiler was replaced at the Municipal Center on October 13 and 14, 2020.

**Frenchman's Creek Park:** The City issued RFP 2021-02 "Vegetation Removal, Site Restoration and Landscape Plantings" and RFP 2021-03 "Playground Renovations" for improvements to Frenchman's Creek Park. These RFPs were posted on the City's website.

**6000 Harland Street Property:** Staff prepared a request for Expressions of Interest for the development of the Harland Street property. At the time of this writing, it is expected that the RFEI will be issued the end of October and that a presentation will be made to the City Council regarding this matter at the Council's December meeting.

**Maryland Green Registry:** The Maryland Green Registry is a free, voluntary program offering tips and resources to help organizations set and meet their sustainability goals. The Green Team Action Plan states that the City will join the Maryland Green Registry. In doing so, the Team gains points from Sustainable Maryland towards recertification. To become part of the Maryland Green Registry, the City must fill out a member profile form, share information regarding at least five environmental practices in place at the City and provide a measurable result related to at least one of these practices. The Green Team, working with staff, has completed the application for the Maryland Green Registry. Benefits of membership in the Maryland Green Registry include: use of the Registry logo; free information and technical assistance with implementing new environmental best practices; information on webinars and conferences to help the City continue its greening efforts; and recognition and eligibility for the annual Maryland Green Registry Leadership Awards.

**MML Fall Conference/Academy of Excellence:** The Maryland Municipal League Virtual Fall Conference was held on October 8 and 9. Mayor Nembhard, Councilmember John, Councilmember Mills, Councilmember Hooks, Alayna Rowlett, Human Resources Administrator, Maisha Williams, Director of Finance and Accounting/Treasurer, Doug Barber, City Clerk and I attended the Academy of Excellence Core classes offered during the Conference, which included Municipal Budgeting, Parts One and Two, and Public Information Act, Parts One and Two.

**Temperature Screenings:** One of the symptoms of COVID-19 is a fever. In an effort to take additional precautionary measures to prevent the spread of COVID-19 during a time when an uptick in COVID-19 is anticipated, the City is installing GoSafe temperature screening stations in every department. The City will screen all employees at the beginning of their shifts and members of the public who enter City facilities. Per the Centers for Disease Control and Prevention guidelines, a person is considered to have a fever if their temperature is 100.4° F or higher. Accordingly, if a person's temperature is greater than 100.4 degrees, the person will not be allowed access to a City facility.

**City of New Carrollton eNewsletter:** As of October 16, the City has 515 people signed up to receive the City's eNewsletter. Please encourage your neighbors to sign up for the eNewsletter by going onto the City of New Carrollton website and, at the bottom of the Home page, filling out the gold form. Let's see if we can double the number of eNewsletter recipients by the time the January/February 2021 Newsletter is issued!

**Issues of interest coming before the City Council:** Maglev November 16, 2020. The Federal Railroad Administration (FRA) and the Maryland Department of Transportation (MDOT) are preparing an Environmental Impact Statement (EIS) to evaluate the potential impacts of constructing and operating a high-speed superconducting magnetic levitation (SCMAGLEV) system between Washington, DC and Baltimore, Maryland with an intermediate stop at BWI Airport.

### CITY OF NEW CARROLLTON National Red Ribbon Week Proclamation (October 23 – October 31, 2020)

**WHEREAS**, the New Carrollton Police Department is the local sponsor of Red Ribbon Week in New Carrollton, Maryland and local government agencies, churches, and the public schools are actively participating in Red Ribbon Week activities; and

**WHEREAS**, communities across America have been plagued by the numerous problems associated with illicit drug use and those that traffic in them; and

**WHEREAS**, there is hope in winning the war on drugs, and that hope lies in education and drug demand reduction, coupled with the hard work and determination of organizations such as the City of New Carrollton Police to foster a healthy, drug-free lifestyle; and

**WHEREAS**, government and community leaders know that citizen support is one of the most effective tools in the effort to reduce the use of illicit drugs in our communities; and

**WHEREAS**, the red ribbon has been chosen as symbol commemorating the work of Enrique “Kiki” Camarena, a Drug Enforcement Administration Special Agent who was murdered in the line of duty, and represents the belief that one person can make a difference; and

**WHEREAS**, the Red Ribbon Campaign was established by Congress in 1988 to encourage a drug free lifestyle and involvement in drug prevention and education efforts; and

**WHEREAS**, October 23 – October 31, 2020, has been designated National Red Ribbon Week, which encourages Americans to wear a red ribbon to show their support for a drug-free environment.

**NOW, THEREFORE, BE IT PROCLAIMED** by the Mayor and Council of the City of New Carrollton, Maryland that the week of October 23 – October 31, 2020, be known as ***National Red Ribbon Week in*** New Carrollton, Maryland.

### **City of New Carrollton: Noise Control**



It is the public policy of the City that every person is entitled to an environment free of noise levels that are detrimental to life, health and enjoyment of property.

No person who has been ordered by a police officer or Code Enforcement Officer to cease using, operating or permitting to be played or operated any radio, television set, tape or disk recorder, phonograph, musical instrument or any other machine, equipment or tool that produces or reproduces any sound or noise that is audible more than fifty (50) feet from the source of the sound or noise shall continue to use, operate or permit to play or operate the device causing the sound or noise.

Notwithstanding anything to the contrary hereinabove, it shall be unlawful for any person at any time of the day or night to make, continue or cause to be made or continued any unreasonably loud noise or any noise that either annoys, disturbs, injures or endangers the comfort, repose, health, peace or safety of others within the corporate limits of the City of New Carrollton and is audible beyond fifty (50) feet from the source of said sound or noise.

### **Prepare Your Car for Winter**

**In addition to annual maintenance, here are some tips to winterize your car:**

- Test your battery; battery power drops as the temperature drops
- Make sure the cooling system is in good working order
- Have winter tires with a deeper, more flexible tread put on your car
- If using all-season tires, check the tread on your tires and replace if less than 2/32 of an inch
- Check the tire pressure; tire pressure drops as the temperature drops
- Check your wiper blades and replace if needed
- Add wiper fluid rated for -30 degrees
- Keep your gas tank at least half full to avoid gas line freeze

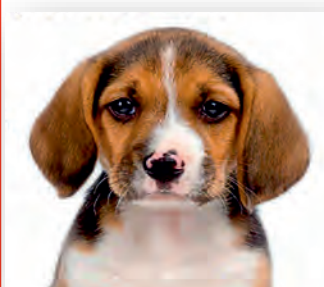
### **Before You Start Out:**

- Clean your car's external camera lenses and side-view mirrors so you'll be able to see what's around you
- Remove dirt, ice, and snow from sensors to allow the assistive-driving features like automatic emergency braking to work
- In frigid weather, you may want to warm up the car before you drive it
- To prevent carbon monoxide poisoning, never leave a vehicle running in your garage – even with the garage door up
- If the forecast looks iffy, wait out the storm if possible; if you must travel, share your travel plans and route with someone before you leave

### **How to Avoid a Crash . AAA offers the following driving tips:**

- Avoid using cruise control in wintry conditions
- Steer in the direction of a skid, so when your wheels regain traction, you don't have to overcorrect to stay in your lane
- Accelerate and decelerate slowly
- Increase following distance to 8 to 10 seconds
- If possible, don't stop when going uphill

If visibility is severely limited due to a whiteout, pull off the road to a safe place and do not drive until conditions improve. Avoid pulling off onto the shoulder unless it is an absolute emergency. Limited visibility means other vehicles can't see yours on the shoulder.

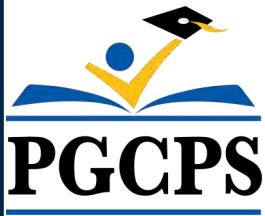
