### State of Maryland Department of Agriculture Mosquito Control Program

The City of New Carrollton participates in the State of Maryland Mosquito Control Program. The programs' adulticiding will begin **May 25, 2022 and continue through September 30, 2022**. Property owners are encouraged to remove any unnecessary water holding containers as they become breeding grounds for mosquitos.

The State has a threshold for mosquito spraying. This influences the amount of insecticide sprayed in a specific area. Spraying for adult mosquitoes will be based on results from standardized surveillance methods and complaints.

Residents might see blinking-lights on public property, these are mosquito traps placed throughout the City. These traps are used for threshold testing.

### CITY OF NEW CARROLLTON CODE PERTAINING TO: OPEN FIRES, BURNING, RECREATIONAL FIRES, AND PORTABLE OUTDOOR FIREPLACE.



**§ 66-3 Prohibited acts.R.** It shall be unlawful for any person to burn any substance on public or private property within the city in an underground pit, on the ground surface or in any container. Only items listed in the definitions of "barbecue," "grill," "outdoor fireplace", and "rotisserie" in § 66-4. Definitions are exempt from this section.



**§ 66-4 Definitions.** As used in this section, the following terms shall have the meanings indicated:

**BARBECUE** A permanent structure made of brick or other decorative nonflammable material, which is constructed for the sole purpose of food preparation.



**CONTAINER** Any device not designed for the sole use of food preparation.

**GRILL** A cooking utensil designed only for food preparation where the food is cooked through exposure to heat.

**OUTDOOR FIREPLACE** A commercial or decorative device utilized to contain small fires for entertainment or warmth.



**ROTISSERIE** An appliance designed only for food preparation on which food is rotated by or over a source of heat.

**UNDERGROUND PIT** Any hole, shaft or cavity in or on the ground utilized for burning.

### LET'S GET MOWING

In the City of New Carrollton grass is to be maintained to a height of 12 inches or less

**66-3 N Weeds, plants and debris.** No owner or occupant of property within the corporate limits of New Carrollton shall cause or permit debris to accumulate or remain or cause or permit weeds, grass, thickets or other growths to grow upon his, her or their property so as to constitute a menace to health or a menace to public safety or a fire hazard or a public nuisance or a nuisance to adjoining property owners or an obstruction to free passage of persons using the sidewalks or streets contiguous to the property. **High grass or weeds in excess of twelve (12) inches in height shall constitute a violation of this section.**

**IMPC 302-4 Weeds:** Premises and exterior property shall be maintained free from weeds or plant growth in excess of 12 inches. Noxious weeds shall be prohibited. Weeds shall be defined as all grasses, annual plants, and vegetation, other than trees or shrub.



### UPDATED - SUBTITLE 11. FIRE SAFETY. DIVISION 4. FIRE PREVENTION CODE.

#### **Sec. 11-268. Open [fires generally.] Burning, Recreational Fires and Portable Outdoor Fireplaces.**

*Open burning will be defined as a fire where material is burned on the ground or in an open receptacle without a chimney or stack. Small recreational fires, such as campfires, are considered open burning. Where permitted by the provisions of Section 19-104, and 19-105 of this County Code, burning by open fires shall be subject to the following conditions:*

##### **OPEN BURN PERMIT REQUIREMENTS:**

Where open burning is being conducted under the terms of a permit issued by the Prince George's County Health Department, the permittee shall be personally responsible for the fire at all times.

The permit shall be in the possession of the person supervising the burning at all times. No persons shall kindle a fire upon the land of another without permission of the owner thereof or the owner's agent. A means of extinguishment will be available at all open burn sites.

The burning of materials of any kind on or within thirty (30) feet of any public roads, streets, highways, alleys, sidewalks, and public rights-of-way shall be prohibited at all times.

Garbage, dead animals, animal waste, tires, plastic, rubber, and other materials which create dense smoke or emissions injurious or noxious to people or property shall not be burned. It shall be unlawful for any person to kindle any open fire except cooking fires, or recreational fires without first notifying Public Safety Communications of such burning.

Except for those fires used for cooking food on property occupied by a single-family dwelling, open fires shall be not less than thirty (30) feet from any building or structure. A clear space free of ignitable materials not less than ten (10) feet in diameter shall be maintained around the fire.

Where burning continues for more than one (1) day, [the Fire/EMS Department] Public Safety Communications shall be notified prior to 8 A.M. on each day of burning.

##### **RECREATIONAL FIRES**

Recreational fires shall be no larger than three (3) feet in diameter. Recreational fires cannot be used to dispose of leaves, branches, brush or other vegetation. Only dry, natural wood may be burned in a recreational fire. Recreational fires will be prohibited during drought conditions, if winds are greater than twelve (12) mph or during an air pollution event (Code Red or Code Orange air quality.)

Fires in fixed or portable outdoor fireplaces, chimneys, and other similar devices fueled only by seasoned dry firewood and used in accordance with the manufacturer's guidelines will be allowed, but subject to the following conditions:

A fire extinguisher or hose must be available during use. Fires must be at least thirty (30) feet from any structure. Fires are not permitted on any balcony or deck. Fires in these devices on or within thirty (30) feet of any public roads, streets, highways, alleys, sidewalks, and public rights-of-way shall be prohibited at all times.

Fixed or portable fireplaces or pits fueled by gas or propane used in accordance with the manufacturer's guidelines at single family dwellings or townhomes will be allowed, but subject to the following conditions: The device must be attended at all times by a person eighteen (18) years of age or older, who is in direct view of the device. A fire extinguisher or hose must be available during use. Use on a deck is permissible, but the device must be at least ten (10) feet from the structure. The combustion area must not be in direct contact with combustible decking.

***Open fires shall be attended at all times by a person 18 years of age or older who is in direct view of the fire until completely extinguished. The Fire Chief or authorized representative may prohibit such burning at any time it is determined that the kindling of an open fire creates a fire hazard. 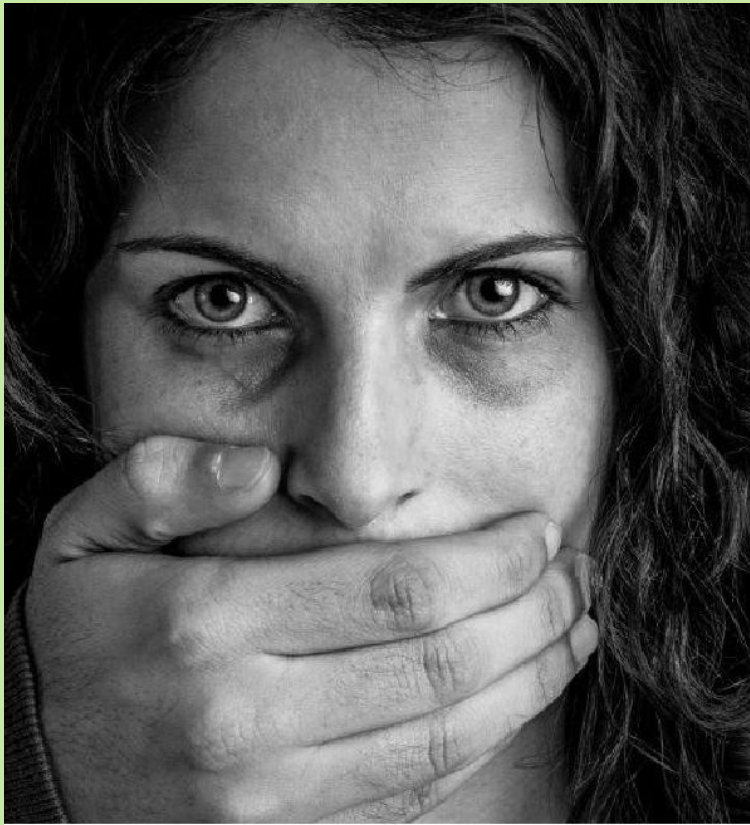

# ANYONE CAN BE A VICTIM OF DOMESTIC VIOLENCE

## STOP THE SILENCE

**Don't believe everything you read and hear about domestic violence. It's not all true!**

### MYTHS

1. Domestic violence does not affect many people. **False.** It affects approximately one million people in the U.S. every year, and 85% of victims are women.
2. Domestic violence is just a momentary loss of temper. **False.** The abuser makes a conscious decision to abuse. Loss of temper is a tool to enforce control through fear, and it is part of a pattern of abuse.
3. Drinking or drug abuse causes domestic violence. **False.** Some abusers make alcohol and drugs an excuse for violent behavior. While there is a correlation between substance abuse and domestic violence, one does not cause the other. However, substance abuse does lower inhibitions and may increase the frequency and severity of abuse.
4. If the abuser is truly sorry and promises to reform, the abuse will stop. **False.** Remorse and begging for forgiveness are manipulative methods used by abusers to control their victims. Abusers rarely stop abusing; in fact, the abuse will almost always get worse as time goes on.
5. Victims have personalities that seek out and encourage abuse. **False.** There is no set of personality traits that universally describes all victims of domestic violence. It's the abuser who is responsible for the abuse, not the victim.



### TRUTHS

Battering is not a mental illness or an anger management issue, but a learned behavioral choice. People who use physical force do so to maintain power and control in relationships. Many abusers grew up in homes where they were abused or witnessed abuse. **If you think you are a victim of domestic violence, remember:**

- (1) You are not alone.
- (2) It is not your fault.
- (3) Help is available.

# DEFINITION

**Domestic and Intimate Partner Violence are behaviors used by one person in a relationship to control the other person. Partners may be married, dating, co-habituating, domestic partners or in a civil union.**

## ANYONE CAN BE A VICTIM!

Victims can be of any age, sex, race, culture, religion, education, socioeconomic or marital status.

## WHAT DOES ABUSE LOOK LIKE?

Abusive behavior is not always just physical or verbal ... it can take on many forms. The abuser misuses power and control that often results in the victim's reduced ability to make choices and live free of fear and intimidation.

# DOES YOUR PARTNER...?

Tease you in hurtful ways in public and in private?

Make or carry out threats to hurt you?

Threaten to leave you?

Threaten to harm himself or herself?

**If so, this is coercive and threatening behavior.**

Prevent you from getting a job or from making your own money?

Limit your access to family income?

**If so, this is economic abuse.**

Treat you like a servant, including making all of the big decisions?

Act like the "master of the castle," including determining each person's role in the home?

**If so, this is the use of personal privilege.**

Make you feel guilty about your children?

Use your children to relay messages between the two of you?

Use visitations with your children to harass you?

Threaten to take your children away?

**If so, this is the use of children for power and control.**

Make light of the abuse and not take your concerns about it serious?

Tell you they did not or do not abuse you?

Shift the responsibility of the abuse to you and say it is your fault it happens?

**If so, this is minimizing, denying and blaming.**

Control what you do, who you see and who you talk to?  
Control what you read and where you go, limiting all of your outside involvement?

**If so, this is the use of isolation.**

If any of these scenarios seem familiar to you, **YOU SHOULD SEEK ASSISTANCE.**

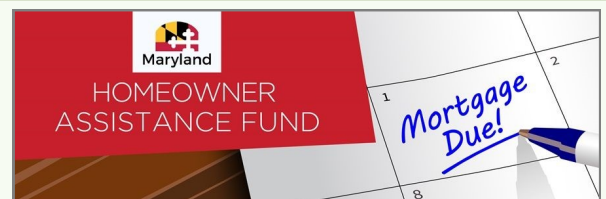
