Budget Amendment Reconciliation No. Two:

To Amend Ordinance 17-01

Current Expense Budget for FY 2017

Effective: February 15, 2017

AN EMERGENCY ORDINANCE OF THE CITY COUNCIL OF NEW CARROLLTON AMENDING THE ADOPTED BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2016 AND ENDING JUNE 30, 2017 AS EMBODIED IN ORDINANCE 17-01 TO REFLECT THE RECEIPT OF ADDITIONAL GRANT FUNDS AND OTHER REVENUES, AND TO ADJUST VARIOUS EXPENDITURES

WHEREAS, the City Council of New Carrollton (the "City Council"), a body politic and corporate of the State of Maryland is authorized to adopt a fiscal year budget, pursuant to City Charter, §C-14 "Budget and Finance"; and

WHEREAS, the City Council adopted a budget for FY 2017 via Ordinance No. 17-01; and

WHEREAS, the City has been awarded grants that were not anticipated at the time the FY 2017 Budget was adopted and the City Council must account for these funds, as well as other unanticipated revenues the City received; and

WHEREAS, certain expenses reflected in the City budget will exceed their appropriated amount and require an adjustment in the FY 2017 Budget to reflect additional money being appropriated to these items; and

WHEREAS, the City Council wishes to amend the FY 2017 Budget to account for new revenues and expenditures since the enactment of the Budget.

WHEREAS, the City Council may, by a four-fifths vote, declare any proposed ordinance or any proposed amendment to an ordinance to be an "emergency" and shall thereupon be authorized to introduce and enact such ordinance or amendment at a single meeting; and

WHEREAS, an emergency ordinance shall become effective on the date specified in the ordinance, but no ordinance shall become effective until approved by the Mayor or passed over his veto by the City Council; and

WHEREAS, the City Council hereby declares that it is in the best interests of the City that this Ordinance be deemed an emergency ordinance so that it may become effective immediately upon approval by the Mayor or when passed over his veto by the City Council.

Section 1. NOW THEREFORE, BE IT ENACTED AND ORDAINED by the City Council of New Carrollton, that Ordinance 17-01, Current Expense Budget for the City of New Carrollton, Maryland for Fiscal Year 2017, under the heading of "City of New Carrollton FY 2017 Adopted Budget" be and hereby is amended as follows:
