#### REQUIRED DOCUMENTS FOR FILING AS A CANDIDATE:

Nominating Petition—The City's Charter requires that a petition contain the valid signatures of ten (10) registered voters who live in New Carrollton. It is recommended that each petition contain several signatures more than the minimum number required in the event that some signatures are found invalid by the City of New Carrollton Board of Elections.

Financial Disclosure Statements—Statements must be filed with the City of New Carrollton Board of Elections by the deadline for nominations. No candidate will be qualified if the required statement is not filed.

Appointment of Campaign Treasurer - The law requires that a Treasurer be appointed, and that his/her appointment be filed with the City of New Carrollton Board of Elections by the deadline for nominations. The Treasurer files periodic reports of income and expenditures incurred concerning the campaign, The first which is due by the nomination deadline. No candidate for public office may designate himself/herself or his/her political agent, Treasurer.

Persons seeking to run for office must be:

- A Citizen of the United States
- A registered voter in Prince George's County
- A New Carrollton resident for a minimum of one-hundred and eighty (180) days preceding the filing deadline for candidacy
- At least 25 years of age at the time of the Election.

Deadline for candidate filing is Friday, April 3, 2015, at 5:00 p.m. Packets for prospective candidates are available for pickup at the New Carrollton Municipal Center, Monday through Friday, 8:30 a.m. until 5:00 p.m.

If you are a registered voter in Prince George's County, you are able to vote in the City of New Carrollton Elections. You must be registered by April 3, 2015, to vote in the May 4, 2015 election. If you have any questions regarding voter registration, please call the Prince George's County Board of Elections at (301) 341-7300.

Persons desiring to vote by Absentee Ballot must submit a request for an Absentee Ballot application to the City Clerk before 5:00 p.m., Friday, April 24, 2015.

Note: Absentee Ballot Applications are available at the Municipal Center, on the City's website at <a href="https://www.newcarrolltonmd.gov">www.newcarrolltonmd.gov</a>, or you may contact the City Administrative Offices at (301) 459-6100 to have an application mailed to you.

#### DEADLINE - Friday, April 24, 2015

Any qualified voters desiring to vote by Absentee Ballot must submit a written request for an Absentee Ballot application to the City Clerk under the authority of the City of New Carrollton Board of Elections, no later than 5:00 p.m.

- ◆ Upon receipt of application, the City of New Carrollton Board of Elections will approve or reject the voter's request for an absentee ballot and, if approved, will mail one (1) ballot to an applicant.
- ◆ An applicant can be rejected if the City of New Carrollton Board of Elections determines upon inquiry that the applicant is not legally qualified to vote at the City Election.
- ♦ The City of New Carrollton Board of Elections must receive all original absentee ballots no later than 8:00 p.m. on election day.

A list will be posted on the City's information board at the New Carrollton Municipal Center containing the names of all individuals deemed qualified to cast an absentee ballot.

#### MAKE YOUR VOICE COUNT! REGISTER, THEN VOTE!

To Vote You Must be a U.S. Citizen who:

- ♦ Is a resident of the City of New Carrollton for at least thirty (30) days. Preceding the election.
- ♦ Is at least 18 years old on or before the date of the General Election.

#### **2015 GENERAL ELECTION**

#### **Instructions & Assistance to Voters**

No voter shall receive any assistance in voting unless he/she completes an affidavit declaring that due to blindness, impaired vision, or physical disability, he/she is unable to vote without assistance.

- ◆ The person filing the affidavit may select any individual or two (2) Election Judges to enter the booth with him/her.
- ◆ The voter may not be assisted by his/her employer or agent.
- ◆ The individual or Election Judges assisting shall operate the machine, as the voter shall direct.

#### **POLL WATCHERS**

Poll Watchers are official observers representing a candidate. They may observe the conduct of the election before, during and after the poll closes.

- ◆ Only one (1) person can be present in the polling place representing a candidate at any given time.
- ◆ The Election Judges may ask all Poll Watchers to leave
- ◆ The Election Judges may cause the removal of any Poll Watcher who is disrupting the election process.
- ◆ Poll Watchers can enter the polling place one-half hour before the opening of the polls.
- ◆ Each Poll Watcher must have credentials issued by the candidate.
- ◆ The Poll Watcher must present these credentials to the Election Judges immediately upon entering the polling place.





Mr. Carlton Marbley Extraordinary Neighbor

This article is written about one of our neighbors here. His name is Carlton Marbley, for many years, Carlton was a high school math teacher at Parkdale Senior High School, When we interviewed Carlton, he had some very interesting stories to tell about children, troubled teens, and the problems that go along with raising children in this day and age.

It seems that between Carlton and his mom, they managed to raise over 50 children (teens) through the school system, mostly from the Department of Social Services. He said he did wonders with the children, while doing all of this with foster children, he managed to help raise his own two children; a daughter at the tender age of 6 years and a son of 4 years.

Although Carlton had assistance from the Department of Social Services he used a lot of his own money to help these kids, and he used his own van for the kids' outings, appointments, and school activities. Some of the kids objected to his ways of discipline when he took on the responsibility, it only took a short time for them to respect him and his house rules, one main rule was honesty and "do your homework." Most all of the children were "Honor Roll", they always went to Sunday school and church, that was non negotiable.

Carlton was definitely a "no nonsense" disciplinarian for misbehaving, one thing that he said was that it was important to get kids to listen and teach them to be respectful and honorable, also, he said none of the kids were sick or had any serious health issues, they are good food and exercised.

Carlton always made sure he listened to the children, Most of them got their learner's permit when they turned 15 years old, and then they got their driver's license, Most of the kids graduated from high school and went on to college, they ended up doing very well with professions paying over \$200.000 a year. A lot of these kids received scholarships, and that made Carlton very proud.

Now at 65 years of age, Duval Senior High Schools wants Carlton to teach track, but he already works part-time at Duval. We will have to wait and see, but rest assured, there is always one more child to help; and we are all grateful for special people like Carlton Marbley and his mom.

#### **CHECK LIST AND TIPS FOR SAFETY**

#### Get your car serviced now.

No one wants to break down in any season, but especially not in cold or snowy winter weather. Start the season off right by ensuring your vehicle is in optimal condition.

TOTAL CITATIONS

Visit your mechanic for a tune-up and other routine maintenance.

» Have your entire vehicle checked thoroughly for leaks, bad worn hoses, or other needed parts, repairs, and replacements.

#### Check your battery.

When the temperature drops, so does battery power. For gasoline-powered engines, be aware that it takes more battery power to start your vehicle in cold weather than in warm. For electric and hybrid vehicles, the driving range is reduced and the battery systems work better after they warm up. Make sure your battery is up to the challenges of winter it.

#### Fill your windshield washer reservoir.

You can go through a lot of windshield wiper fluid fairly quickly in a single snowstorm, so be prepared for whatever Mother Nature might send your way.

- » Completely fill your vehicle's reservoir before the first snow hits.
- Use high-quality, "no-freeze" fluid.
- » Buy extra to keep on hand in your vehicle.

#### Check your windshield wipers and defrosters.

Safe winter driving depends on achieving and maintaining the best visibility possible.

- » Make sure your windshield wipers work and replace worn blades.
- Consider installing heavy-duty winter wipers if you live in an area that gets a lot of snow and ice.
- » Check to see that your window defrosters (front and rear) work properly.



Incorrect or improperly installed floor mats in your vehicle may interfere with the operation of the accelerator or brake pedal, increasing the risk of a crash. Remember these tips when installing new floor mats to ensure safe operation of your vehicle:

- Remove old mats before the installation of new mats.
- Never stack mats, as that may increase the potential for pedal interference.
- Be sure to follow the manufacturer's instructions for mat installation and use the available retention clips to secure the mat in the proper position. This will prevent the mat from sliding forward.
- Check that the mats are the correct size and fit for the vehicle and do not interfere with the full operation of the foot controls (accelerator, brake and clutch pedals). Whenever the interior of the vehicle is cleaned or the mats have been removed for any reason, verify that the driver mat has been reinstalled correctly.
- » Keep a tire pressure gauge in your vehicle at all times and check pressure when tires are "cold" - meaning they haven't been driven on for at least three hours.
- Look closely at your tread and replace tires that have uneven wear or insufficient tread. Tread should be at least 1/16 of an inch or greater on all tires.

Effective February 1, 2014, the City of New Carrollton began enforcing a new leaf bag ordinance, prohibiting the use of plastic bags for **yard waste** collection. In accordance with Prince George's County Department of Environmental Resources (DER) law <u>CB-87-2012</u>; residents who bag their **yard waste** must put the yard waste out for pickup in **paper bags. Yard waste** includes any greenery that grows out of the ground; grass, shrubs, branches, leaves, etc. All other collection requirements will stay the same. 

Did you know? Temporary electric power for holiday decorative lighting may not exceed ninety (90) days. The City of New Carrollton requires that all temporary exterior lights and decorations be removed after the holiday season.

#### **City Requirements for Construction Dumpsters**

- Permits are required for the placement of a dumpster or storage container on residential property. Permits must be obtained by the property owner or a licensed contractor doing work covered under a building permit.
- Only one (1) construction dumpster shall be allowed per lot.
- Must be placed a minimum of six (6) feet from the property line.
- Container size is limited and may not exceed eight (8) feet in height, eight (8) feet in width and sixteen feet in length.
- It is unlawful to place any type of container on a street or other public property.
- Failing to obtain a city permit for a dumpster or storage container shall be a municipal infraction, subject to fines and penalties.
