2017 City Election



State of Maryland Mosquito Control Program

The City of New Carrollton is participating in the State of Maryland's Mosquito Control Program. Over the summer the State will be monitoring mosquito counts throughout the City and spraying as appropriate. Spraying will occur in the City on Thursday evenings when the mosquito count justifies it.



There has been some concern voiced to the State from Prince George's County residents regarding the mosquito spray being used. To clarify, the pesticide used is a truck-based spray called Permanone 30-30, which is permethrin-based. There has been some concern voiced about the use of the pesticide Naled. We have been assured by the State Department of Agriculture Mosquito Control Program does not spray Naled anywhere in Prince George's County. Paper Recycling Bins

A reminder to the residents that the Paper Retriever Bins are for recycling of paper and cardboard only. Trash, electronics or bulk items are not allowed and violators may be fined for dumping prohibited items.

Smoke Detectors Save Lives:

The majority of fatal home fires happen at night, when people are asleep.

Contrary to popular belief, the smell of smoke may not awaken a sleeping person. The poisonous gases and smoke produced by a fire can numb the senses and put you into a deeper sleep.

Inexpensive household smoke detectors sound an alarm alerting you to a fire by giving you time to escape. Smoke detectors cut your risk of dying in a home fire nearly in half.

Is One Smoke Detector Enough: Every home should have a smoke detector outside of every sleeping area and on every level of the home, including the basement.

Fire and building codes also require a smoke detector in every bedroom for new construction. On floors without bedrooms, detectors should be installed in or near living areas, such as dens, living rooms, or family rooms.

Wall mounted units should be installed so that the top of the detector is 4 to 12 inches from the ceiling. A ceiling mounted detector should be installed at least four inches from the nearest wall. In a room with a pitched ceiling, mount the detector at or near the ceilings highest point.

Chapter 67 of the Code of the City of New Carrollton: Noise Control

67-01 Declaration of Policy: The City hereby declares it to be the public policy of the City that every person is entitled to an environment free of noise levels which are detrimental to life, health and enjoyment of property. The purpose of this chapter of the New Carrollton City Code is to establish the lawful and unlawful limits of noise within the City and the enforcement procedures and requirements pertaining thereto.

67-2 General Prohibition: (A) No person who has been ordered by a police officer or Code Enforcement Officer to cease using, operating or permitting to be played or operated any radio, television set, tape or disk recorder, phonograph, musical instrument or any other machine, equipment or tool which produces or reproduces any sound or noise which is audible more than fifty (50) feet from the source of the sound or noise shall continue to use, operate or permit to play or operate the device causing the sound or noise.

67-3 Unreasonably loud noise: Not withstanding anything to the contrary hereinabove, it shall be unlawful for any person at any time of the day or night to make, continue or cause to be made or continued any unreasonably loud noise or any noise which either annoys, disturbs, injures or endangers the comfort, repose, health, peace or safety of others within the corporate limits of the City of New Carrollton and is audible beyond fifty (50) feet from the source of said sound or noise.
