Council Legislative Meeting – Wednesday, June 21, 2017

Ordinance 17-08: Change to City of New Carrollton Code Chapter 27 Purchasing and Contracts (First Reading)

Motion: I move that the Council introduce Ordinance 17-08, an ordinance that updates the City of New Carrollton Code Chapter 27 Purchasing and Contracts, by updating the City's purchasing and contract requirements **(First Reading) – Rosenberg/Dodro (Vote: 4-0-0)**

Resolution 17-05: Authorizing the City of New Carrollton to seek \$1.5 Million in General Obligation Bond Financing

Motion: I move that the Council adopt Resolution 17-05, a resolution of the Council of the City of New Carrollton, a municipal corporation of the State of Maryland (The "Issuer"), providing for the issuance and sale of an aggregate principal amount not to exceed One Million Five Hundred Thousand Dollars (\$1,500,000) of Bonds of the Issuer, to be known as "City of New Carrollton Infrastructure Bonds, 2017 Series A" (or by such other or additional designation or designations as required by the Community Development Administration identified herein) (The "Bonds"), to be issued and sold pursuant to the authority of sections 4-101 through 4-255 of the Housing and Community Development Article of the Annotated Code of Maryland, as amended, for the purpose of providing all or a portion of the funds necessary for (I) financing or refinancing or refinancing costs of repairs and renovations to the issuer's municipal center, (II) funding a portion of a Capital Reserve Fund and/or (III) paying issuance and other costs related to the bonds; providing that the bonds shall be issued upon the full faith and credit of the issuer; providing for the disbursement of the proceeds of the sale of the bonds and for the levy of annual taxes upon all assessable property within the corporate limits of the issuer for the payment of the principal of and interest on the bonds as they shall respectively come due; providing for the form, tenor, denominations, maturity date or dates and other provisions of the bonds; providing for the sale of the bonds; and providing for related purposes, including, without limitations, the method of fixing the interest rate or rates to be borne by the bonds, the approval, execution and delivery of documents, agreements, certificates and instruments, and the making of or providing for the making of representations and covenants concerning the tax status of interest on the bonds. – **Rosenberg/Robbins (Vote: 4-0-0)**

Cooperation Agreement for Community Development Block Grant (CDBG) Funds – Federal Fiscal Years 2018-2020

Motion: I move that the Council authorize the Mayor to sign the Cooperation Agreement with Prince George's County Community Development Block Grant (CDBG) to be eligible to participate in the CDBG program beginning July 1, 2017 through June 30, 2020. – **Robbins/Rosenberg (Vote: 4-0-0)**

Sharing the Road Safely with School Buses

School buses are one of the safest forms of transportation on the road today. In fact, according to the National Highway Traffic Safety Administration, riding a bus to school is 13 times safer than riding in a passenger vehicle and 10 times safer than walking to school. The reality of school bus safety is that more children are hurt outside the bus than inside as passengers. Most of the children who lose their lives in bus-related crashes are pedestrians.

Elementary age children get hit by motorists illegally passing a stopped school bus. For this reason, it is necessary to know the proper laws and procedures for sharing the road safely with school buses.

All 50 states have a law making it illegal to pass a school bus that is stopped to load or unload children.

All 50 states require that traffic in both directions stop on undivided roadways when students are entering or exiting a school bus.

Highlights from the Department of Public Works:



The bridge over Briars Mill Run on Carrollton Parkway has been closed by Prince Georges's County Department of Public Works & Transportation as a safety precaution until repairs or replacement can be done. There is no time frame for either at this time.

The sidewalk work at Bicentennial Hill located on Westbrook Drive is nearly completed. There is a utility box that needs to be lowered so that the last block can be installed.

The Washington Suburban Sannitary Commission "WSSC" is doing a water main improvement project on 85th Avenue in front of the Metro Points Hotel. The New Carrollton Department of Public Works will be in contact with WSSC to monitor and to ensure that there is minimal impact to the residents during the project.

The new bio-retention area at Public Works Facility is nearing completion. The final step of the project will be to install trees and shrubs in the area.


The paving contractor has started the paving in the City. Citizens are asked to please observe the "No Parking Signs" to ensure that the paving project can be completed in a timely manner.

As the seasons start to change and outside temperatures start to drop, please have your furnace and fireplaces serviced and inspected by an approved and licensed contractor registered in the State of Maryland.

If you do have a fireplace and/or any gas appliance please obtain a carbon monoxide detector.

Every year people are injured and die from these deadly fumes, we do not want our families to go through these tragedies.



Informational Announcement:



Trash Container Lid Requirement Residents of the City of New Carrollton:

Chapter 63: Recycling and Refuse of the City of the City of New Carrollton Code of governs the storing of trash on residential properties and requires that all trash containers have a secure fitting lid. Specifically:

63-2 Requirements relating to refuse collection containers for standard City service.

A. Single-family and household refuse must be placed in watertight, heavy plastic or metal containers that do not exceed thirty-five (35) gallons in capacity and are equipped with tight-fitting covers, which covers shall remain on the containers at all times. Garbage shall be placed in plastic bags prior to being placed in containers. The containers shall be kept in a sanitary condition.

It is very important for the health and safety of not only your residence, but also those around you, that you properly secure your refuse. Garbage containers without proper covers, or garbage in the open, attracts rodents and other scavenger animals which can carry disease and/or be dangerous to residents.

Per Chapter 1, Article IV, Section 1.21 – General Penalties: Any person found guilty of violating a provision of this Code shall be subject to a minimum fine of fifty dollars (\$50.00) and a maximum fine of one thousand dollars (\$1,000) for repeated offenses.

Please also ensure that you have enough garbage containers with secure lids for the residence. If you are unable to fully seal the lid of your trash container(s), or have to put bags on the ground, we recommend that you get another trash container.

This Information Alert is intended to serve notice to all residents of New Carrollton that effective September 1, 2017, our Code Enforcement Officers will begin enforcing this code provision to provide proper fitting tops for your refuse container(s). You are advised that failure to do so be a violation of the Code and will result in the minimum fine of \$50. Each subsequent re-inspection and failure will result in additional fines.

Anuncio informativo: Requiere Tapas En Los Recipientes de Basura



Atencion: Residentes de la Ciudad de New Carrollton:

Capitulo 63: Reciclaje y Basura de la Ciudad de New Carrollton Código que gobierna el almacenamiento de basura en zona o propiedades residenciales, requiere que todos los contenedores de basura se mantengan cerrados con tapas en todo momento . Específicamente:

63-2 Requisitos relacionado con el servicio de basura estandar; recipientes de basura,.

A. Las basuras de residencias unifamiliares y domésticas deben colocarse en recipientes de plástico o metal o recipientes de plástico pesado no debe exceder treinta y cinco (35) galones en capacidad y debe estar equipado y cerrar correctamente con tapas las cuales deben permanecer cerradas con tapa en todo momento. La basura debe colocarse en bolsas de plástico antes de ser colocadas en contenedores. Los contenedores de basura deberán mantenerse en un estado sanitario.

Es muy importante para el bien estar y la salud de los residents y personas a su alrededor. Los contenedores de basura sin cubiertas adecuadas, o basura al aire libre, atrae ratas y otros animales que pueden portar enfermedades y / o ser peligrosos para la salud de las personas.

Capitulo 1, Artículo IV, Seccion 1.21 – Sanciones: Cualquier persona encontrada culpable de violar una disposición de este debera ser sujeto a una multa minima de cincuenta dolares (\$50.00) y o una multa maxima de mil dolares (\$1,000) por ofensas repetidas.

Favor asegúrese de tener suficiente contenedores de basura con tapas en su propiedad. Si no puede sellar completamente la tapa de su (s) contenedor (es) de basura, o tiene que poner bolsas en el suelo, le recomendamos que obtenga otro contenedor de basura.

Esta Alerta de Información tiene la intención de notificar a todos los residentes de New Carrollton que **efectivo el 1ro de Septiembre del 2017** nuestros inspectores del departamento de Código comenzarán a hacer cumplir esta provisión de código para asegurarse que todas las propiedades esten usando tapas apropiadas para su contenedor de basura. Se aconseja que si no lo hace será una violación del Código resultará en una multa mínima de \$50 dolares. Cada inspección subsiguiente y o fracaso resultará en multas adicionales.


