On Thursday, November 3, 2016, The Friends of New Carrollton Police Foundation, Inc., family members, and other officials celebrated with Mr. Albert W. Turner, Developer and the very first Mayor of the City of New Carrollton in honor of his 100th birthday and his accomplishments throughout the years.

Mr. Turner a native resident of Prince George's County, Maryland, built his first 75 single family homes by age 21; Mr. Turner then served three years in the United States Navy during WWII, upon his return built an additional 125 homes in Montgomery County and Prince George's County; Mr. Turner in 1949, launched MCD Enterprises, which focused on developing residential communities throughout Maryland; Mr. Turner in the early 1950's built and incorporated what we know today as the City of New Carrollton, as well as serving as the first Mayor of the City; Mr. Turner has been honored by many for his passion to envision, create, and build lasting communities for future generations to enjoy.

I congratulate the Honorable Albert W. Turner for his accomplishments throughout the years, and extend best wishes to him and much happiness for many more years to come.

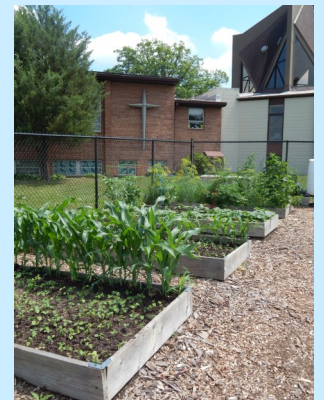

### **"NEW" Snow and Ice Emergency Plan - Declaration of a Snow Emergency - 11-16-16**



Chapter 100-5 of the New Carrollton Code governs Declarations of Snow Emergencies:

In the event of a predicted or actual snow fall of four inches (4") or more, alternative parking shall be authorized on all streets maintained by the City where parking is permitted.

During a snow event of four inches (4") or more, alternative parking will allow citizens to park vehicles on sidewalks and grassy areas of their own property for the sole purpose of clearing the streets for plowing. All vehicles must be moved from sidewalks and grassy areas within 48 hours of the end of the storm. The Public Works Department will plow curb to curb, where possible, immediately after the end of the snow fall. There will be no more attempts made thereafter to plow curb to curb. Streets with cars parked on them will not be cleared curb to curb.

A snow, ice or other event that requires the implementation of allowing alternate parking shall be publicized on the City Comcast television Channel 71 and City Verizon television Channel 30 along with the City's Website ([www.newcarrolltonmd.gov](http://www.newcarrolltonmd.gov)) and social media outlets (Facebook and Twitter). The City will also publicize the information on Metro area television and radio public broadcasts, with said broadcasts deemed sufficient for enforcement of this plan.

It shall be unlawful to clear snow from private property and to place it in a City street. Snow must be placed in the tree box between the curb and sidewalk. When clearing snow from around a vehicle parked on a street, snow removed from around the vehicle also must be placed in the tree box.

Any vehicle which is parked in such a manner that it blocks normal travel lanes shall be issued a citation for such violation and be subject to being towed and impounded by the City Police Department.

**Any person issued a citation for a violation of this subsection C(4) shall be subject to a fine of two hundred fifty dollars (\$250).**

Reminder to City residents: A car running with keys in the ignition unattended can be dangerous, and it gives an opportunity for thieves to steal your vehicle. I remind residents that letting your vehicle run unattended puts it at risk for being stolen or at risk of getting a Maryland State Citation.

There are a few simple steps you can take to reduce the risk of losing your car to a thief:

**Stay in the car.** It is better to be cold for a few minutes in your car while it warms up than to be left in the cold when a thief drives it away.

**Lock the doors.** Use a second key to be able to lock the car after starting it.

**Get a remote starter.** Remote starters are the safest, and only legal way to keep your car running while unattended. With the key out of the ignition, a thief can't put the car in gear.

**Use a club.** Lock the steering wheel with a "Club" steering wheel lock to discourage thieves from targeting your car.

### Safe Winter Driving Practices

Despite record-breaking warm temperatures in parts of the country, winter is here, accompanied by the usual arrival of snow, ice and the hazardous roads such weather produces. While winter can be an enjoyable time of year, we must take special care of our vehicles and pay particular attention to our driving during these colder months to stay safe on the road.

**Service your vehicle now.** No one wants to break down in any season, but especially not in cold or snowy winter weather. Start the season off right by ensuring your vehicle is in optimal condition.

**Visit your mechanic for a tune-up or other routine maintenance.** Have your entire vehicle checked thoroughly for any leaks, bad hoses, or other needed part repairs or replacements. Be sure to check the fluid levels, tires, hoses and belts at least once a month.

If you plan to use snow tires, have them installed now. Check out [www.safercar.gov](http://www.safercar.gov) for tire ratings before purchasing new ones. For existing tires, check to ensure they're properly inflated (as recommended by your vehicle manufacturer), the tread is sufficient with no uneven wear, and that the rubber is in overall good condition. Note that tire rubber starts to degrade after several years, and tires need to be replaced even if they have not seen much wear. Check your battery, and fill the washer reservoir.

### SNOW PLOWING

Residents should make every effort to park their cars in the driveway when snow is



forecast. When cars are removed from the streets it makes it easier for snowplows to do its job, to plow curb-to-curb without any interference. Vehicles parked on the street interfere with Public Works' personnel to properly plow, making it necessary to re-plow the streets. As a result, driveways become buried, and affected, residents will have the burden of digging out their vehicles. It is not the City's responsibility to assist in clearing residential driveways.



### CHRISTMAS TREE RECYCLING

Trees must be stripped of ornaments, tinsel, and all other decorations. Trees must be placed where they are visible from the street, but NOT at the curb for pick-up.

**Trees will be picked up on the last pick-up of the week.**

The first shot of winter arrived on Saturday, December 19, 2016, with freezing rain. The roadways were pretreated with salt. A Public Works crew was on hand from 5:00 a.m. till noon on that day to make sure the roads had salt as needed. Public Works Department is prepared and ready for the winter, trucks have been prepared and the salt-bin is full for the upcoming season.

The last few months the Department of Public Works has been working on paving streets, which is half way complete, but has been suspended in the mean time due to rain and harsh weather conditions; street paving will resume in the spring 2017.

City residents requested that the City repair the sign entryway located at Lamont Drive and Riverdale Road; the sign has been repaired and refreshed. The entryway sign at 85th Avenue and Route 450 Annapolis Road was repaired earlier in the year.

I want to thank the Public Works employees for their hard work and dedication to the City. I wish all employees a happy prosperous new year, keep up the great work.

I want to wish all residents a happy new year. I also want to remind residents to be careful throughout the winter season, and to be prepared and ready for any winter weather storms.

### **Fire and Life Safety Issues During the Winter Months**

The potential impact of the winter may cause disruption in electrical service in our homes. The following are easy to follow tips which will help residents when using alternative light and electrical sources during power outages:

- Use flashlights during power outages instead of candles. Keep plenty of fresh batteries on hand at all times. If you prefer the look of candles, consider flameless battery operated candles that offer the flickering light without the potential fire hazard.
- If using candles, make sure they are placed on a stable piece of furniture in sturdy holders that will not tip over.
- Keep candles away from anything combustible, such as clothing, books, paper, curtains, or decorations.
- Check portable electric heaters for frayed/damaged wires and ensure they are clean and placed on a flat level surface. Use only “listed” by an approved testing laboratory equipment and follow manufacturer’s instructions.
- Do not use extension cords with portable space heaters, the extension cord can overheat and cause a fire.
- If you use kerosene fuel fired fire heaters, use only “K-1” kerosene fuel. Never fill the unit inside, instead remove it to the exterior after it has cooled down than refuel.
- Open a window enough to provide proper ventilation for fuel burning appliances.
- Make sure your smoke alarms are working properly by testing them. Additionally, ensure your guests are aware of all available exits if a fire would occur and have them meet at a designated location outside.

Residents are reminded to make every attempt to reach out to the elderly to ensure they are prepared and safe during winter weather. We encourage you to, if possible to offer to pick up essential items for the elderly and test their smoke alarms and carbon monoxide detectors.
