# **ELECTION INFORMATION**

The City of New Carrollton Board of Elections certified only two candidates for the three council seats that are open for the 2017 City of New Carrollton's General Election scheduled for on Monday, May 1, 2017. The Board would like to remind everyone of the write-in provisions contained in the City of New Carrollton Election Handbook, which are as follows:

#### **QUALIFICATIONS FOR CANDIDACY**

All interested candidates must satisfy the following four criteria to run for office in the City of New Carrollton. A candidate must be:

- A registered voter of the State of Maryland and the City of New Carrollton A.
- At least 25 years of age at the time of Election В.
- C. A citizen of the United States
- A New Carrollton resident for a minimum of one-hundred-eighty (180) days preceding D. the filing deadline for candidacy (October 2, 2016)

#### WRITE-IN CANDIDATE PROVISIONS

- A voter in a City election may write in the name of any person for the A. office of Mayor or Councilmember in the method provided by the City Clerk on Election Day. A voter may write in only one name for each office.
- B. All write-in candidates must be qualified at the time of the election to be eligible to hold the office of Mayor or Councilmember. All write-in candidates must meet all the requirements contained in the City Charter and City Code concerning who may be a candidate for the office of Mayor or Councilmember prior to being sworn in. The City Board of Elections shall certify that both of the above requirements have been met prior to any write-in candidate taking office. If a write-in candidate who wins election cannot meet any of the above requirements, the sitting Mayor or Councilmember shall continue in office until a special election for such office can be held.

ABSENTEE BALLOT DEADLINE - Friday, April 28, 2017

Any qualified voters desiring to vote by Absentee Ballot must request an Absentee Ballot application under the authority of the City of New Carrollton Board of Elections, no later than Friday, April 28, 2017, 5:00 p.m.

# **Voting in the May 1, 2017 General Election**

To vote in the May 1, 2017 General Election, you must already be registered to vote with a New Carrollton address in Prince George's County. Not sure if you're registered? Call 301-341-7300 or check your registration online at www.elections.state.md.us.

#### ASSISTANCE TO VOTERS

A voter who has impaired vision or other physical disability or is otherwise incapable of casting a ballot without assistance may be assisted in voting by any person selected by the voter (except his employer) or by any Election Clerk. A person casting a ballot on behalf of such a voter shall execute a certification that he or she is rendering assistance at the voter's request without attempting to influence the voter in any manner.

#### POLL WATCHERS

Poll Watchers are official observers representing a candidate. They may observe the conduct of the election before, during and after the poll closes.

- Only one (1) person can be present in the polling place representing a candidate at any given time.
- The Election Clerks may ask all Poll Watchers to leave.
