

### **Highlights of the Mayor**



Administered the Oath of Office for the position of Mayor to Duane Rosenberg by Prince George's County Clerk of the Court (Designee) and Mr. Charles Davis, Board of Elections Chair

Andy Hanko was our Mayor for the 15 years I served as your City Councilman. Residents would often caution me never to challenge our "Mayor for life" for the Mayoral seat. So when Andy decided not to run for re-election, I was excited to run myself and was sworn in as your Mayor on May 16, 2018, stepping in for Andy after his 34-year Mayoral tenure. Andy passed away on May 19, 2018. "Mayor for life" was an apt phrase for a guy who served us in elected capacity for 48 years; 14 as Councilman and 34 as Mayor. At Andy's May 25, 2018, funeral repast, our County Council Chairwoman, Danielle Glaros, presented the Hanko family with a proclamation (on the next page) honoring Andy for his public service, along with recognizing numerous other lifetime accomplishments. May the proclamation stand as a tribute to Mayor Hanko, and to remind us the County Council designated May 25<sup>th</sup> as "Mayor Hanko Day."

My first few weeks as Mayor have been filled with study, briefings and meetings. I've reviewed the City's Park Master Plan for park development opportunities, studied the numerous and potential economic development projects in our business community, and continued to work with staff on the upcoming renovations to City Hall and other City facilities. I've been to many homes and have had dozens of visitors to my office. My door is always open. Please feel free to stop by or call.

Please join me in welcoming our two new City Councilmembers, Phelecia Nembhard and Roy Peterson. I look forward to working with them and the entire council as we address upcoming initiatives. I'd also like to recognize the Honorable Katrina Dodro for her 12 years of service on the City Council. I know Katrina will remain active in the City. Thank you, Katrina.

Summer is a pretty time in the City. Our gardens are award winning, the pool is drawing crowds, the tennis courts keep active, and bikers and joggers are everywhere. Our library is scheduled to open before the beginning of the next school year. Wishing everyone an enjoyable summer season. #### Call-A-Bus

New Carrollton Department of Public Works handles the **Call-A-Bus** program. The number to call for questions about registration and reservations is **301-577-1008.** 

The New Carrollton Call-A-Bus offers lift-equipped, door to door free transportation for New Carrollton Senior Citizens (age 55 and older), individuals with disabilities, and veterans for medical appointments, hospital visits, shopping and social activities within a 5 mile radius.

48 hour advanced reservation is required, appointments are scheduled on a first-come first serve basis, and priority is given to seniors and individuals with disabilities going to medical appointments.

Individuals with children four years of age and under must be secured in a child safety seat provided by the passenger.

This service is available Monday through Friday from 9:15 a.m. until 2:30 p.m. (Except on holidays or if Prince George's County schools are closed or delayed due to harsh weather).

#### 41-1: Permit required:

In order to preserve and maintain the public health, safety and an orderly development within the City of New Carrollton and to avoid encroachments upon building restrictions, it shall be unlawful for any person, firm or corporation to erect, construct or repair or anywise change any building, garage, carport or other building or addition thereto, or any other structure, including a wall, fence or barrier of any kind, or to make any other improvements of a permanent nature to or upon any real property within the corporate limits of the City of New Carrollton until plans and specifications for the construction thereof and a plat plan for the lot or parcel of ground upon which the same is to be erected, constructed or altered shall have been submitted to the Mayor of New Carrollton or his or her designee, and a permit issued by the Mayor or his or her designee for the same; provided, however, that permits for construction or reconstruction on any property in a commercial or industrial zone or any construction valued in excess of thirty thousand dollars (\$30,000) in a residential zone shall be approved by the City Council.

#### Chapter 67 of the Code of the City of New Carrollton: Noise Control

67-01 Declaration of Policy: The City hereby declares it to be the public policy of the City that every person is entitled to an environment free of noise levels which are detrimental to life, health and enjoyment of property. The purpose of this chapter of the New Carrollton City Code is to establish the lawful and unlawful limits of noise within the City and the enforcement procedures and requirements pertaining thereto.

67-2 General Prohibition: (A) No person who has been ordered by a police officer or Code Enforcement Officer to cease using, operating or permitting to be played or operated any radio, television set, tape or disk recorder, phonograph, musical instrument or any other machine, equipment or tool which produces or reproduces any sound or noise which is audible more than fifty (50) feet from the source of the sound or noise shall continue to use, operate or permit to play or operate the device causing the sound or noise.

67-3 Unreasonably loud noise: Not withstanding anything to the contrary hereinabove, it shall be unlawful for any person at any time of the day or night to make, continue or cause to be made or continued any unreasonably loud noise or any noise which either annoys, disturbs, injures or endangers the comfort, repose, health, peace or safety of others within the corporate limits of the City of New Carrollton and is audible beyond fifty (50) feet from the source of said sound or noise.


