# CITY OF NEW CARROLLTON MINUTES OF CITY COUNCIL LEGISLATIVE MEETING WEDNESDAY, FEBRUARY 15, 2017

The meeting was called to order at 7:00 p.m. on Wednesday, February 15, 2017, in the Council Chambers of the Municipal Center by Chairman Sarah Potter Robbins. Attending were Chairman Sarah Potter Robbins, Vice Chair Lincoln Lashley, Councilmembers Duane Rosenberg, Richard Bechtold, Katrina R. Dodro, and Mayor Andrew C. Hanko, Interim Administrative Officer Joseph Nagro, Director of Public Works Bernard Cochran, Lt. Vincent Lyew, Treasurer Diane Dawes and City Clerk Doug Barber.

#### 1. Call to Order/Pledge of Allegiance

Chairman Robbins welcomed everyone and asked Mr. Rosenberg to lead the Pledge of Allegiance.

#### 2. Report of the Treasurer - Consideration of Bills

Treasurer Dawes presented the Treasurer's Report: Batch #1 (January 19, 2017); Batch #2 (January 26, 2017); Batch #3 (February 2, 2017); and Batch #4 (February 9, 2017) the bills totaled \$246,808.58. There were 4 bills in excess of \$10,000. There was no discussion. Mr. Rosenberg moved to accept the report with a copy being attached to the minutes; seconded by Mr. Lashley. Chairman Robbins called for the vote. The motion was approved (5-0-0).

Motion: Mr. Lashley moved that the Council adopt Emergency Ordinance 17-05, an Ordinance of the City Council of New Carrollton amending the Adopted Budget for the fiscal year beginning July 1, 2016 and ending June 30, 2017 as embodied in Ordinance 17-01 to reflect the receipt of additional grant funds and other revenues, and to adjust various expenditures. The motion was seconded by Mr. Rosenberg. There was no discussion. Chairman Robbins called for the vote. The motion was approved (5-0-0).

#### Ordinance 17-06 Chapter 12: Ethics (First Reading)

**Motion:** Ms. Dodro moved that the Council introduce Ordinance 17-06, an Ordinance of the City Council of New Carrollton amending Chapter 12 "Ethics" Code of the City of New Carrollton, §12-6 and §12-7 to change the financial disclosure requirements for certain employees. The motion was seconded by Mr. Rosenberg. There was no discussion. Chairman Robbins called for the vote. The motion to postpone adoption of Ordinance 17-06 until the next legislative meeting was approved (5-0-0).

#### **FCC Cell Tower Coalition**

**Motion:** Mr. Rosenberg moved that the City of New Carrollton join the Maryland Coalition, represented by Best, Best and Krieger, who will provide legal support to challenge private companies from becoming utility contractors and allowing them to put cell towers in City right-of-ways. Mr. Rosenberg further moved that the City Council direct the City administration to sign the Retainer Agreement with Best, Best and Krieger and remit \$2,000 to cover the City's pro-rated cost. The motion was seconded by Ms. Dodro. There was no discussion. Chairman Robbins called for the vote. The motion was approved (5-0-0).

There being no further business Mr. Rosenberg moved to adjourn the City Council Legislative Meeting of Wednesday, February 15, 2017, seconded by Mr. Lashley. The motion was approved (5-0-0).
