# CITY OF NEW CARROLLTON MINUTES OF CITY COUNCIL LEGISLATIVE MEETING WEDNESDAY, JANUARY 18, 2017

The meeting was called to order at 7:00 p.m., on Wednesday, January 18, 2017, in the Council Chambers of the Municipal Center by Chairman Sarah Potter Robbins. Attending were Chairman Sarah Potter Robbins, Vice Chair Lincoln Lashley, Councilmembers, Duane Rosenberg, Richard Bechtold, Katrina R. Dodro and; Mayor Andrew C. Hanko, Interim Administrative Officer Joseph Nagro, Assistant Administrative Officer Timothy George, Assistant Director of Public Works Andre Triplett, Chief of Police David Rice, Treasurer Diane Dawes and City Clerk Doug Barber.

### 1. CALL TO ORDER/PLEDGE OF ALLEGIANCE

Chairman Robbins welcomed everyone and asked Ms. Dodro to lead the Pledge of Allegiance.

#### 2. REPORT OF THE TREASURER - CONSIDERATION OF BILLS

Treasurer Dawes presented the Treasurer's Report: Batch #1 (December 22, 2016); Batch #2 (December 29, 2016); Batch #3 (January 5, 2017); and Batch #4 (January 12, 2017) the bills totaled \$691,787.82. There were 3 bills in excess of \$10,000. There was no discussion. Mr. Rosenberg moved to accept the report with a copy being attached to the minutes; seconded by Ms. Dodro. Chairman Robbins called for the vote. The motion was approved (5-0-0).

Mr. Bechtold moved that the following minutes be approved: City Council Workshop Meeting of December 19, 2016; and City Council Legislative Meeting Minutes of December 21, 2016. Mr. Lashley seconded the motion. Ms. Dodro noted that as she did not attend the meetings she would be abstaining from the vote. There was no other discussion. Chairman Robbins called for the vote. The motion was approved (4-0-1).

Ms. Dodro advised that the Maryland Municipal League held their Annual Legislative Session Opening Day Reception on Wednesday, January 11, 2017, in Annapolis, Maryland. #### City Website Redesign Consultant Selection

**Motion:** Ms. Dodro noted that the City of New Carrollton issued a RFP for website redesign services. Upon evaluating the five submitted proposals and ranking them according to the criteria and qualification requirements presented in the posted RFP, City staff has determined that CivicLive submitted the lowest responsible proposal and recommends that the City award the website redesign contract to CivicLive. Accordingly, Ms. Dodro moved that the City of New Carrollton award the City

website redesign contract to CivicLive in the amount of \$25,455, and that the Mayor be authorized to sign a contract to that effect in a form that is substantially the same as that presented to the Council tonight, seconded by Mr. Rosenberg. Assistant Administrative Officer George provided a brief overview on the City's process for the website redesign project. Chairman Robbins called for the vote. The motion was approved (5-0-0).

There being no further business Mr. Rosenberg moved to adjourn the City Council Legislative Meeting of Wednesday, January 18, 2017, seconded by Mr. Lashley. The motion was approved (5-0-0).
