The City Council Legislative Meeting was held at 7:06 p.m., on Wednesday, May 15, 2019, in the Council Meeting Room # 220 of the Municipal Center. Attending were Vice Chair Lincoln Lashley, Councilmembers, Sarah Potter Robbins, Roy A. Peterson, Stephen L. John and Phelecia Nembhard, Mayor Duane Rosenberg, City Administrative Officer Timothy George, Director of Finance and Accounting/Treasurer Maisha Williams and City Clerk Doug Barber.

1. CALL TO ORDER

Vice Chair Lashley welcomed everyone and called the meeting to order.

2. Public Hearing - Ordinance 19-15 Chapter 63: Recycling and Refuse

7. ORDINANCE 19-17: OPERATING AND CAPITAL BUDGET FOR THE CITY OF NEW CARROLLTON, MARYLAND FISCAL YEAR 2020 (SECOND READING)

Motion: Mr. Peterson moved that the Council adopt Ordinance 19-17, an Ordinance of the City Council of New Carrollton adopting an annual operating and capital budget for the City of New Carrollton for the fiscal year beginning July 1, 2019 and ending June 30, 2020; establishing the tax rate to be levied upon the taxable property within the City; authorizing the collection of such taxes, liens and unpaid fees; adopting annual budgets for the commercial and/or industrial properties special public safety taxing districts; and all things generally relating to the adoption of an annual budget for the City (Second Reading). Mr. John seconded the motion. There was no discussion. Vice Chair Lashley called for the vote. The motion was approved (5-0-0).

9. RESOLUTION 19-19 FY 2020 SCHEDULE OF FEES

Motion: Ms. Nembhard moved that the Council adopt Resolution 19-19, a resolution adopting a schedule of fees for FY 2020 (Second Reading). Ms. Robbins seconded the motion. There was no discussion. Vice Chair Lashley called for the vote. The motion was approved (5-0-0).

10. ORDINANCE 19-15 CHAPTER 63: RECYCLING AND REFUSE (SECOND READING)

Motion: Mr. John moved that the Council adopt Ordinance 19-15, an Ordinance of the City Council of New Carrollton amending Chapter 63 "Recycling and Refuse," to clarify what may be set out for collection as Special Bulky Items (§ 63-4), to provide for the removal of property eviction set-outs (§ 63-4A), to clarify that fees will be charged for the City to

remove recycling, refuse, special bulky items and property eviction set-outs that are not properly disposed of or handled (§ 63-4, § 63-4A, § 63-6, § 63-8 and § 63-9) and to clarify that it is the property owner's obligation to ensure compliance with the City Code, Chapter 63(§ 63-9) (Second Reading). Mr. Peterson seconded the motion. There was no discussion. Vice Chair Lashley called for the vote. The motion was approved (5-0-0).

11. RE-APPOINTMENT OF THE WEINBACH SCHOLARSHIP COMMITTEE

Motion: Mr. John moved that the Council accept Mayor Rosenberg's re-appointment of Ms. Florence Hendershot, Ms. Peggy Kwik, Ms. Jane Michalek, and Mr. Charles Davis to the Weinbach Scholarship Committee for a one year term (June 20, 2019 – June 20, 2020). Ms. Robbins seconded the motion. There was no discussion. Vice Chair Lashley called for the vote. The motion was approved (5-0-0).

12. RESOLUTION 19-20 SUSTAINABLE PURCHASE POLICY

Motion: Mr. Peterson moved that the Council adopt Resolution 19-20, a Resolution of the City Council of New Carrollton adopting a sustainable purchasing policy. Ms. Robbins seconded the motion. There was no discussion. Vice Chair Lashley called for the vote. The motion was approved (5-0-0).

13. ORDINANCE 19-18 CHAPTER 35: ANIMAL CONTROL (FIRST READING)

Motion: Ms. Robbins moved that the Council introduce Ordinance 19-18, an Ordinance of the City Council repealing and re-enacting with amendments Chapter 35 "Animal Control" of the Code of the City of New Carrollton for the purpose of removing provisions that allow the City to operate an animal control facility and to provide various services associated with the operation of such a facility and to require the removal of pet waste from private property under certain circumstances (First Reading). Ms. Nembhard seconded the motion. There was no discussion. Vice Chair Lashley called for the vote. The motion was approved (5-0-0).
