7. ADOPTION OF FY2020 COUNCIL MEETING SCHEDULE

Motion: Mr. Lashley moved that the Council adopt the FY2020 Council Meeting Schedule as presented. Ms. Robbins seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (5-0-0).

8. DISCUSSION OF RECYCLE CONTRACT

Motion: Ms. Robbins moved that the Council award the residential recycling contract to Goode Companies, Inc., a Maryland Corporation, for a one-year term beginning July 25, 2019, in an amount not to exceed \$125,130.00, in substantially the same form as presented to the Council and authorize the Mayor to sign the contract. Mr. Peterson seconded the motion. The Council discussed the issue at length. The Council each expressed their comments and concerns for the public work employees and the effects to the employees with the added duties. The Council requested that the staff review and make a concerted effort to review how the collection of recycling is handled in the City of New Carrollton. Ms. Robbins called the question. Mr. Peterson seconded the motion. A roll call vote was taken on calling the question. The motion to call the question passed unanimously. Chair Nembhard called for the vote on the official motion. The motion was approved (5-0-0).

9. EMERGENCY ORDINANCE 20-01 BUDGET AMENDMENT RECONCILIATION NO. ONE: TO AMEND ORDINANCE 19-17 CURRENT EXPENSE BUDGET FOR FY2020

The Mayor and Council discussed at length the proposed addition to the proposed budget amendment to include the funds to purchase additional police vehicles. Chief Rice provided additional information to the Council and provided reasons for the request. Chief Rice noted to the Council that the proposed action only allowed for the funding to be allocated and protocol still would have be followed to purchase vehicles. Ms. Robbins called the question. Mr. Peterson seconded the motion. A roll call vote was taken on calling the question. The motion to call the question passed unanimously. **Motion:** Mr. Peterson moved that the Council adopt Emergency Ordinance 20-01 an Emergency Ordinance for the City Council of New Carrollton amending the adopted budget for the fiscal year beginning July 1, 2019 and ending June 30, 2020 as embodied in Ordinance 19-17 to reflect money brought into the budget from City Restricted/Designated Funds, add additional revenues, and to adjust various expenditures. Ms. Robbins seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (5-0-0).
