9. CHARTER AMENDMENT RESOLUTION 20-01: INCREASING THE MEMBERSHIP OF THE BOARD OF ELECTIONS (SECOND READING)

Motion: Ms. Robbins moved that the Council adopt 20-01, a Charter Amendment Resolution of the City Council of New Carrollton amending the Charter of the City of New Carrollton, §C-5 "Board of Elections" to increase the number of members of the Board of Elections from three to five (Second Reading). Mr. Lashley seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (5-0-0).

10. CHARTER AMENDMENT RESOLUTION 20-02: PROCESS FOR FILLING MAYOR AND COUNCIL VACANCIES (SECOND READING)

Motion: Mr. John moved that the Council adopt 20-02, a Charter Amendment Resolution of the City Council of New Carrollton amending the Charter of the City of New Carrollton, §C-3 "Government of the City" to change the method of filling vacancies in the office of the Mayor and any Councilmember (Second Reading). Mr. Peterson seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (4-1-0). Councilmember Robbins voted against the motion.

11. ORDINANCE 20-07 CHAPTER 50: ELECTIONS (SECOND READING)

Motion: Mr. Peterson moved that the Council adopt 20-07, an Ordinance of the City Council of New Carrollton amending City Code, Chapter 50 "Elections", §50-36 "Vote Count" and Repealing and Re-Enacting in its entirety, with amendments, §50-37 "Challengers and Watchers" to clarify who may be present in the polling place on Election Day after the closing of the polls (Second Reading). Mr. Lashley seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (5-0-0).

12. NEW BUSINESS

There was no new business to be discussed.
