CITY OF NEW CARROLLTON MINUTES COUNCIL WORKSHOP MEETING – VIRTUAL MEETING MONDAY, APRIL 13, 2020

The Council Workshop Meeting was held at 7:11 p.m., on Monday, April 13, 2020, as a virtual meeting. Attending were Chair Phelecia Nembhard, Councilmembers Roy A. Peterson, Lincoln Lashley, Stephen L. John, Sarah Potter Robbins, Mayor Duane Rosenberg, City Administrative Officer Tim George, Assistant City Administrative Officer Karen Ruff, Chief of Police David Rice, Major William Everts, and City Clerk Doug Barber

1. CALL TO ORDER

Chair Nembhard welcomed everyone and called the meeting to order.

2. REPORT OF THE MAYOR AND ADMINISTRATION

Mayor Rosenberg reported that he is serving on Delegate Anne Healey's scholarship committee. Mayor Rosenberg also thanked the residents for sending their stories on how they are handling the pandemic. Mayor Rosenberg closed his report by advising the Council that Interim Director of Public Works Nagro provided a written report but was excused from attending the meeting.

City Administrative Officer George addressed the Council and noted the requirement in Prince George's County regarding the wearing facial masks in public places. Mr. George closed his report by noting the new feature on the City's website: Constant Contact and encouraged residents to sign up to receive official City Information.

Chief of Police Rice noted that the Easter Bunny was in the City on Easter. Chief Rice reported the number of COVID-19 cases (64) confirmed in the 20784 zip code as of April 13, 2020. Chief Rice closed his report by providing the March 2020 police stats.
