# 11. ORDINANCE 20-11 CITY CODE CHAPTER 105 TAXATION (FIRST READING)

Motion: Mr. Lashley moved that the Council introduce Ordinance 20-11, an Ordinance of the City Council of New Carrollton, Maryland, amending the Code of the City of New Carrollton, Chapter 105 Taxation, Article III.. Special Public Safety Taxing Districts, §105-5 Special Public Taxing Districts Generally; Districts Created; Applicability, to delete addresses from the description of the Special Public Safety Taxing Districts, to clarify that the Multifamily Special Public Safety Taxing District shall include both apartments and condominiums, to provide for when there would be a zero tax rate for a Special Public Safety Taxing District, and other nonsubstantive changes (First Reading). Ms. Robbins seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (5-0-0).

# 12. CHARTER AMENDMENT RESOLUTION 20-03 SUSPENDING CERTAIN STATE LAW REQUIREMENTS AND PERMITTING VOTING BY MAIL

**Motion:** Mr. John moved that the Council adopt Charter Amendment Resolution 20-03, a Resolution of the City of New Carrollton, Maryland for Purposes of Amending the Charter of the City of New Carrollton authorizing the City Council to amend, suspend, revise, alter, and add to certain provisions of the Charter including, but not limited to, instituting voting by mail, in the event of a state of emergency declared in Maryland or Prince George's County. Mr. Peterson seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (5-0-0).

#### 13. RESOLUTION 20-10 PURPOSES OF POSTPONING THE MAY 4, 2020 CITY ELECTION

**Motion:** Mr. Peterson moved that the Council adopt Resolution 20-10, a Resolution of the City Council of New Carrollton, Maryland, for purposes of postponing the May 4, 2020 City Election. Ms. Robbins seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (5-0-0).

# 14. RESOLUTION 20-11 PURPOSES OF INSTITUTING VOTING BY MAIL FOR THE 2020 ELECTION

Motion: Mr. Lashley moved that the Council adopt Resolution 20-11, a Resolution of the City Council of New Carrollton, Maryland, for purposes of instituting voting by mail for the 2020 election due to an existing state of emergency and catastrophic health emergency caused by COVID 19. Ms. Robbins seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (5-0-0).

# 15. EMERGENCY ORDINANCE 20-12 ADDING SECTION 50-39 TO CHAPTER 50 ELECTIONS

**Motion:** Ms. Robbins moved that the Council adopt Ordinance 20-11, an Emergency Ordinance of the City Council of New Carrollton adding section 50-39 to Chapter 50 of the City Code authorizing the suspension, alteration, or amendment of any and all provisions in Chapter 50 by the City Council in the event of a State of Emergency or Public Health Emergency. Mr. Peterson seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (5-0-0).

## 16. RESOLUTION 20-12 APPROVAL OF REVISED 2020 ELECTION CALENDAR

**Motion:** Mr. Lashley moved that the Council adopt Resolution 20-12, a Resolution of the City Council of New Carrollton approving the City 2020 General Election Timeline. Mr. John seconded the motion. There was no discussion. Chair Nembhard called for the vote. The motion was approved (5-0-0).
