

**CITY OF NEW CARROLLTON MINUTES  
LEGISLATIVE MEETING  
WEDNESDAY, FEBRUARY 17, 2021**

The Council Legislative Meeting was held at 7:10 p.m., on Wednesday, February 17, 2021, as a virtual meeting. Attending were Chair Lincoln Lashley, Councilmembers, Stephen L. John, Sarah Potter Robbins, Allyne Hooks, Cynthia DB Mills, Mayor Phelecia Nembhard, Interim City Administrative Officer Joseph Nagro, Chief of Police David Rice, Director of Public Works Andre Triplett, and City Clerk Doug Barber.

**1. CALL TO ORDER**

Chair Lashley welcomed everyone and called the meeting to order.

7. **EMERGENCY ORDINANCE 21-08 CHAPTER 50 ELECTIONS**

**Motion:** Ms. Hooks moved that the City Council adopt Emergency Ordinance 21-08, an Ordinance of the City Council of New Carrollton, Maryland to amend, City Code Chapter 50, "Elections", to adopt changes to §50-4 Campaign Treasurer; §50-7 Electioneering; Adding §50-8 Campaign Signs; adding Article II General Election Procedures adding voting by mail provisions and re-numbering of sections (Emergency Ordinance). Ms. Robbins seconded the motion. There was no discussion. Chair Lashley called for the vote. The motion was approved (5-0-0).

8. **RESOLUTION 21-08 APPROVING 2021 ELECTION AS A VOTE BY MAIL ELECTION**

**Motion:** Ms. Mills moved that the City Council adopt Resolution 21-08, a Resolution of the City Council of New Carrollton declaring the City of New Carrollton's 2021 Election to be a Vote-By-Mail Election. Ms. Robbins seconded the motion. There was no discussion. Chair Lashley called for the vote. The motion was approved (5-0-0).

9. **AUTHORIZE THE PURCHASE OF FREIGHT LINER BOOM TRUCK – DEPARTMENT OF PUBLIC WORKS**

**Motion:** Mr. John moved that the City Council authorize the purchase of a 2021 Freight Liner M2 106 Boom Truck from Custom Truck One Source (12660 East Lynchburg Salem Turnpike, Forest, Virginia) in the amount of \$141,069.00. Ms. Mills seconded the motion. There was no discussion. Chair Lashley called for the vote. The motion was approved (5-0-0).

10. **AUTHORIZATION TO PURCHASE TWO MOBILE MESSAGE SIGN BOARDS**

**Motion:** Ms. Robbins moved that the City Council authorize the purchase of two Mobile Message Sign Boards from National Capital Industries, Inc. (3420 Kenilworth Avenue, Bladensburg, Maryland) in the amount of \$36,118.44. Ms. Hooks seconded the motion. There was no discussion. Chair Lashley called for the vote. The motion was approved (5-0-0).

11. **BOARD OF ELECTIONS COMMITTEE APPOINTMENT – MS. GWEN CHASE**


