CITY OF NEW CARROLLTON MINUTES COUNCIL WORKSHOP MEETING MONDAY, MARCH 15, 2021

The Council Workshop Meeting was held at 7:10 p.m., on Monday, March 15, 2021, as a virtual meeting. Attending were Chair Lincoln Lashley, Councilmembers, Stephen L. John, Sarah Potter Robbins, Allyne Hooks, and Cynthia DB Mills, Mayor Phelecia Nembhard, Interim City Administrative Officer Joseph Nagro, Lt. Vincent Lyew, Director of Public Works Andre Triplett and City Clerk Doug Barber. Chief of Police David G. Rice was absent.

1. CALL TO ORDER

Chair Lashley welcomed everyone and called the meeting to order.

2. PRESENTATION - WEST LANHAM HILLS VOLUNTEER FIRE DEPARTMENT - DEPUTY CHIEF SCOTT VASQUEZ

Deputy Chief Scott Vasquez provided an update to the Council on the West Lanham Hills Volunteer Fire Department. Deputy Chief Vasquez responded to questions given by the Mayor and Council on the financial state of the department. Mayor Nembhard and the entire City Council thanked Deputy Chief Vasquez and his department for their dedicated service to the residents of the City of New Carrollton.

3. REPORT OF THE MAYOR AND ADMINISTRATION

Director of Public Works Triplett provided an official written report to the City Council. Mr. Triplett provided the City Council with a status update on the Clean Water Partnership project in the City, as it is nearing completion. Mr. Triplett closed his report by providing the stats for February 2021.

Interim City Administrative Officer Nagro provided the Council with an official written report. Mr. Nagro provided an update on the Frenchman's Creek Playground Project and he thanked City Clerk Barber for all his work in getting the project submitted to the State of Maryland Board of Public Works. Mayor Nembhard extended prayers for Councilmember Mills. Mayor Nembhard took a moment to read an extensive list of accomplishments completed by the City of New Carrollton since she was elected in June 2020.

Ms. Hooks had no announcement. Ms. Hooks addressed her concerns with children playing in the creeks in the City. Mr. Triplett advised that signs will be placed in and around the creeks to deter children from playing in the creeks.
