

**CITY OF NEW CARROLLTON MINUTES
LEGISLATIVE MEETING
WEDNESDAY, MARCH 17, 2021**

The Council Legislative Meeting was held at 7:11 p.m., on Wednesday, March 17, 2021, as a virtual meeting. Attending were Chair Lincoln Lashley, Councilmembers, Stephen L. John, Sarah Potter Robbins, Allyne Hooks, Cynthia DB Mills, Mayor Phelecia Nembhard, Interim City Administrative Officer Joseph Nagro, Director of Public Works Andre Triplett, and City Clerk Doug Barber. Chief of Police David Rice was absent.

1. CALL TO ORDER

Chair Lashley welcomed everyone and called the meeting to order. Mr. Lashley requested a moment of silence for Mr. Percy Wines, former custodian for the City of New Carrollton.

Motion: Ms. Robbins moved that the following Council Meeting Minutes be approved: Council Workshop Minutes (February 3, 2021), Council Workshop Meeting Minutes (February 16, 2021) and Council Legislative Meeting Minutes (February 17, 2021). Ms. Mills seconded the motion. There was no discussion. Chair Lashley called for the vote. The motion was approved (5-0-0).

Motion: Mr. John moved that the City Council along with the Mayor proclaim April 22, 2021, as Earth Day in the City of New Carrollton. Ms. Hooks seconded the motion. There was no discussion. Chair Lashley called for the vote. The motion was approved (5-0-0).

9. **AUTHORIZE THE PURCHASE OF AN ELECTRIC VEHICLE FOR THE OFFICE OF CODE ENFORCEMENT**

Motion: Ms. Robbins moved that the City Council authorize the purchase of a 2020 Nissan Leaf SV Electric Vehicle from Criswell Automotive Fleet Sales (503 Quince Orchard Road, Gaithersburg, Maryland 20878) in the amount of \$32,443. Ms. Hooks seconded the motion. There was no discussion. Chair Lashley called for the vote. The motion was approved (5-0-0).

10. **ZONING AND APPEALS BOARD COMMITTEE APPOINTMENT – MS. AMINA AJAY**

Motion: Ms. Hooks moved that the City Council approve the Mayor's appointment of Ms. Amina Ajay as a member of the City of New Carrollton's Zoning and Appeals Board to serve term ending on March 17, 2023. Ms. Mills seconded the motion. There was no discussion. Chair Lashley called for the vote. The motion was approved (4-1-0). Mr. John abstained.

11. **ZONING AND APPEALS BOARD COMMITTEE APPOINTMENT – MS. BIBI SATAR-WILSON**

Motion: Ms. Mills moved that the City Council approve the Mayor's appointment of Ms. Bibi Satar-Wilson as a member of the City of New Carrollton's Zoning and Appeals Board to serve a term ending on March 17, 2023. Ms. Robbins seconded the motion. There was no discussion. Chair Lashley called for the vote. The motion was approved (4-1-0). Mr. John abstained.

12. ZONING AND APPEALS BOARD COMMITTEE APPOINTMENT – Ms. DOREEN LAMBERT


