CITY OF NEW CARROLLTON MINUTES COUNCIL WORKSHOP MEETING WEDNESDAY, APRIL 7, 2021

The Special Council Workshop Meeting was held at 7:13 p.m., on Wednesday, April 7, 2021, as a virtual meeting. Attending were Chair Lincoln Lashley, Councilmembers, Stephen L. 1. CALL TO ORDER

2. REPORT OF THE MAYOR AND ADMINISTRATION

Chief Rice thanked all the other department directors for the collaboration with the many events taking place in the City. Chief advised residents to contact "911" in an emergency and not the Chief or Mayor Nembhard as it only will delay the response in assistance by the medical professionals.

Director of Public Works Triplett addressed the Council with an update that the Community Gardens in the City were open, the Senior Van program has started running daily, and the annual park clean-ups will begin next week. Mr. Triplett closed by advising the Council and residents that the street sweeper was in the City for the remainder of the week.
