# CITY OF NEW CARROLLTON MINUTES COUNCIL WORKSHOP MEETING MONDAY, APRIL 19, 2021

The Council Workshop Meeting was held at 7:06 p.m., on Monday, April 19, 2021, as a virtual meeting. Attending were Chair Lincoln Lashley, Councilmembers, Stephen L. John, Sarah Potter Robbins, Allyne Hooks, and Cynthia DB Mills, Mayor Phelecia Nembhard, Interim City Administrative Officer Joseph Nagro, Chief of Police David G. Rice, Director of Public Works Andre Triplett, Human Resources Administrator Alayna Rowlett, and City Clerk Doug Barber.

#### 1. CALL TO ORDER

Chair Lashley welcomed everyone and called the meeting to order.

## 2. REPORT OF THE MAYOR AND ADMINISTRATION

Interim City Administrative Officer Nagro provided the Council with an official written report. Mr. Nagro provided an update on the Frenchman's Creek Playground Project and he thanked City Clerk Barber for all his work in getting the project submitted to the State of Maryland Board of Public Works. Mr. Nagro closed his report by noting that his main focus would be working with Mayor Nembhard and the other departments to prepare the FY 2022 Budget.

Director of Public Works Triplett provided an official written report to the City Council. Mr. Triplett provided the City Council with a status update on the Clean Water Partnership project in the City. Mr. Triplett advised that the City of New Carrollton has been designated Tree City U.S.A. for fourteen consecutive years. Mr. Triplett closed his report by providing the stats for March 2021.

Chief of Police Rice briefed the Council on the calls for concerns posted on the department's Facebook page daily and provided clarification to the report. Chief Rice closed his report by providing the Council with the March 2021 police stats.

Mayor Nembhard closed by noting the many initiatives taking place in the City since her election as Mayor of New Carrollton.
