MINUTES OF CITY COUNCIL MEETING CITY OF NEW CARROLLTON APRIL 21, 1999

The regularly scheduled meeting of the City Council of the City of New Carrollton was held in the New Carrollton Municipal Center on Wednesday, April 21, 1999.

The meeting was called to order by Chairman Raymond J. Garvey. Present were Council Members James H. Fippin, Rose M. Hurdle, Sarah C. Potter, and John A. Schaffer; Mayor Andrew C. Hanko, Administrative Officer Mark L. Latour, Public Works Director Richard L. Robbins, and Treasurer Duane Rosenberg.

1. PLEDGE OF ALLEGIANCE.

Chairman Garvey announced that there would be a moment of silence before the meeting in honor of the students who were injured and murdered in Colorado this afternoon. Afterwards, he led the Pledge of Allegiance.

2. **REPORT OF THE MAYOR.**

Mayor Hanko offered heart felt sympathy and condolences to the parents and families of those students and teachers that were killed in the Columbine <u>High School</u>, <u>Littleton</u>, <u>Colorado</u>, shootings.

Mayor Hanko announced that there would be a 40th anniversary celebration at the National Space Agency on May 2, from 9:00 a.m. to 4:00 p.m. The Mayor briefly listed some of the many activities planned for the event, and he stated that all New Carrollton residents were invited.

Mayor Hanko reported that he attended the Brotherly Love International recognition program a week ago Saturday; and on behalf of the Council and residents, he thanked Reverend Yancey and his volunteers for the excellent job they are doing for the youth of New Carrollton.

The Mayor announced that the City has a new organization, and it was called the New Carrollton Men's and Women's Club. The club is dedicated to the youth in New Carrollton, and it is still seeking new members ages 21 years or older.

Mayor Hanko was invited to observe Arbor Day at Carrollton Elementary School last Friday. A special tree was donated and planted this year by Bozzuto Landscaping

Company; and it was a seedling from the Rambo apple tree that is a direct descendant of Johnny Appleseed's original tree.

Mayor Hanko attended the New Carrollton Garden Club's 40th anniversary celebration this past Saturday; and on behalf of the Council and residents he extended the City's thanks for all they have done for the City.

Mayor Hanko announced that the Vera Cope Weinbach Scholarship Committee would host a spaghetti dinner this Saturday, from 4:30 to 8:00 p.m. All residents were invited to attend the open house at the Municipal Center during the hours of the dinner.

Mayor Hanko reported about an incident on Thursday evening involving an apprehension and an arrest in connection with a domestic breaking and entering; and he stated that one of the City's Contract Police Officers was first on the scene.

Mayor Hanko reported that he received a letter from Major Hunt containing the results of a traffic study done on Riverdale Road, between Route 450 and Lamont Drive. The officers wrote 107 citations, and they also recovered a stolen vehicle.

Mayor Hanko reported that the City's Contract Police Officers made two arrests for auto theft, and he explained that the incident was a direct result of keys being left in the vehicle. The Mayor urged residents not to leave the keys in their car, and he also cautioned the residents not to leave the motor running while the car is unattended.

Mayor Hanko read a letter that he had received from Jones Communications stating that the City would receive two checks as its pro-rata share of the settlement for claims against Jones. The letter further explained that this is the City's portion of the \$500,000 put up by Mr. John Askew's coalition, and the checks were in the amount of \$50,389 and \$16,178. The Mayor recommended that he would like to see this money go towards the City's roads program.

Mayor Hanko also read a letter that he had received from County Executive Wayne Curry explaining that he had approved the City's request for a Community Based Development Block Grant to renovate the old City Hall building. Mr. Curry would now forward the grant to the County Council for approval. Chairman Garvey suggested that the Mayor send copies of both of the letters to County Councilman Tom Hendershot.

Council Member Fippin congratulated both the Mayor and Council Member Hurdle for getting this far with the grant to remodel old City Hall. Council Member Potter commended the Mayor for the change and tidy appearance of Room 230.

Council Member Hurdle asked Mr. Robbins about some extensive digging in the vicinity of old City Hall, and Mr. Robbins responded that this was being done by the Washington Suburban Sanitary Commission. Mrs. Hurdle also mentioned some fallen branches or trees that appeared to have fallen over wires in the area at the end of Preston Street in the woods; and Mr. Robbins responded that he would call the electric company, if necessary.

Council Member Schaffer commented on the \$100,000 Community Based Block Grant approved by Mr. Curry for the renovation of old City Hall, and the Mayor explained that this amount is the most that can be awarded in one year.

Mr. Schaffer asked that the City's Contract Police Officers patrol the area of Westbrook Drive exiting the City to the Beltway at approximately 7:00 a.m. weekday mornings, because he has observed speeding there.

Mr. Schaffer complimented the Mayor for doing such a good job in organizing the new Educational Committee and selecting members for it. Mr. Schaffer stated that he is the Chairman of that committee, and the first meeting was held Tuesday night.

The Mayor responded that he felt proud of his selection of the members and the chairman. Chairman Garvey agreed with the Mayor, and he explained that Mayor Hanko could not have picked a better committee chairman.

Chairman Garvey reported that he had received a letter from Mr. Jim Estep, the Chairman of the Prince George's County Council, regarding open hazardous materials. This item cleared the Transportation and Environment Committee on March 5, and there was a public hearing in the County Administration Building.

3. **REPORT OF THE TREASURER.**

Treasurer Rosenberg reported that there were 48 invoices, and they totaled \$125,769.00. Mr. Rosenberg had reviewed those invoices, and he recommended that the bills be paid. Based on the recommendation of the Treasurer, Council Member Potter moved that the bills be paid, and a copy of the list be attached to the minutes of this meeting. Council Member Fippin seconded the motion.

Chairman Garvey suggested that the administration ask the City Attorney if the bills could be rounded off to the nearest dollar, because this might save money in accounting fees. Mr. Latour responded that he would do so. The Chairman then called for the vote, and the motion was unanimously (5-0) approved.

4. CONSIDERATION OF MINUTES OF THE APRIL 5, 1999, COUNCIL WORKSHOP MEETING.

Council Member Hurdle moved that the minutes be approved as presented. Council Member Potter seconded the motion, and it was unanimously (5-0) approved.

CONSIDERATION OF MINUTES OF THE APRIL 7, 1999, COUNCIL MEETING.

Council Member Potter moved that the minutes be approved as presented. Council Member Hurdle seconded the motion, and it was unanimously (5-0) approved.

CONSIDERATION OF MINUTES OF THE APRIL 12, 1999, SPECIAL COUNCIL MEETING.

Council Member Potter moved that the minutes be approved as presented. Council Member Hurdle seconded the motion, and it was unanimously (5-0) approved.

5. PUBLIC HEARING-ON PROPOSED ORDINANCE NO. 99-03 TO ENACT A NEW CHAPTER 10 OF THE <u>CODE OF ORDINANCES OF THE CITY</u> <u>OF NEW CARROLLTON, MARYLAND, 1997 EDITION, ENTITLED</u> "EMERGENCY PREPAREDNESS PLAN" FOR THE PURPOSE OF LAYING THE GROUND WORK FOR A COORDINATED RESPONSE TO A WIDE RANGE OF SITUATIONS WHICH REPRESENT SIGNIFICANT RISK TO PROPERTY, SEVERE IMPACTS TO THE ENVIRONMENT, AND MOST IMPORTANTLY, HAZARDS TO HUMAN HEALTH OR LIFE.

Chairman Garvey explained that this would set up an emergency command center within the City, with the Mayor in charge. There would be no telephone testimony, and Mr. Latour stated that no written testimony had been received. Therefore, the Chairman declared the public hearing held.

6. **REPORTS OF THE COUNCIL.**

Council Member Schaffer reported about the new Education Committee, and he stated that the five schools in New Carrollton were represented in the members. Mr. Schaffer briefly listed the names of those members, and he stated that the Mayor began the meeting by distributing copies of a Maryland Municipal League publication that he had

read last fall. An article in the magazine pointed out that only crime was a greater concern that education, and this was a result of a survey in 157 cities and towns. The purpose of the committee was discussed, and Mr. Schaffer suggested that their motto be "it takes a village to raise a child." Mr. Schaffer explained the history of this statement, and he summarized that more volunteers are necessary in order to meet the needs of the schools.

Mr. Schaffer reported that he met the new Manager of the Ramada, Mr. Brian Lee, and Mr. Lee informed Mr. Schaffer that while the computer shows causing traffic problems in the City would continue for the rest of this year, the show had outgrown the facilities at the Ramada. Therefore, the shows would not be held at the Ramada next year.

Mr. Schaffer urged residents to come out and vote on May 3, and he explained that there was a very important issue on the ballot. Mr. Schaffer explained that he was in the process of preparing a flyer discussing the issue.

Mr. Schaffer stated that he was looking forward to the spaghetti dinner on Saturday afternoon hosted by the Vera Cope Weinbach Scholarship Committee.

Council Member Hurdle commented with sadness on the shooting incident in Colorado, and she stated that she felt it was good thing that the City is doing in regard to the new Education Committee. Mrs. Hurdle applauded Mr. Schaffer for being the chairman of that committee, and she stated that she knew Mr. Schaffer would do a good job. Mrs. Hurdle reminded Mr. Schaffer that the <u>Sentinel</u> newspaper offered quite a few scholarships for the children of the City.

Mrs. Hurdle reported that she attended the City business meeting with the Prince George's County Police and the local merchants, and she noted that there had been no representation from Carrollton Enterprises during the past few meetings.

Council Member Hurdle reported that she also attended the Arbor Day celebration at Carrollton Elementary School, and she also attended the New Carrollton Garden Club's 40th anniversary celebration. Mrs. Hurdle explained that she was now a member of the Garden Club, and she enjoyed the presentation followed by the buffet luncheon.

Council Member Hurdle mentioned that residents might see yellow trucks working in the City, and she explained that the outside gas line and meter system was being updated every three years. Mrs. Hurdle explained that if residents did not know where cut off valves were located, they could call Mr. William Shepard at (703) 750-1000.

Mrs. Hurdle commented on the many telephone calls she had received from residents regarding their high water bills, and she requested that a representative from Washington Suburban Sanitary Commission be invited to a Council meeting to explain the reasons for these high bills.

Mrs. Hurdle sent cookies to the bake sale held by the Friends of the New Carrollton Library, and the next meeting is Thursday, May 20, at 7:00 p.m.

Mr. Stewart gave Mrs. Hurdle applications for the Prince George's County Beautification Awards, and she stated that they would be available at the Municipal Center. Please send in all entries by May 28.

Mrs. Hurdle attended the International Brotherly Love celebration, and she stated that this organization really makes a difference for the children. They are located inside of Carrollton Mall.

Mrs. Hurdle reported that she had copies of Council Resolution 11 regarding the Community Based Block Grant for old City Hall, and it included information about the amounts all of the cities and towns are going to receive. Mrs. Hurdle stated that she would request that some of the funds in the City's prior year receipts be used towards funding this project, if the County Council approves this resolution.

Council Member Potter also attended the Brotherly Love International recognition program, and she felt that it was important to have children in programs like this where they were getting supplementary training in educational, spiritual, and personal development. Mrs. Potter hoped that the kind of work that they were doing might help to prevent the kind of situation we have all seen this week on television.

Mrs. Potter commended Ms. Gaines, the Principal of Carrollton Elementary School, for her work; and she also stated that the Arbor Day celebration was lovely.

Mrs. Potter congratulated the members of the Garden Club for their celebration, and she stated that they were the ground-breakers of some of the beautification we see today.

Mrs. Potter enjoyed the New Carrollton Men's and Women's Club, and she explained that there were many activities planned for the future for the youth of the City.

Council Member Potter reported that she attended a reception at Government House that was held by Governor and Mrs. Glendening on April 8^{th.} She reported that a lot more would be heard from Lt. Governor Kathleen Kennedy Townsend, as the Lt. Governor moved forward with her plans to run for Governor.

Mrs. Potter stated that she looked forward to the spaghetti dinner on Saturday evening, and she stated that she had sold 11 tickets. A discussion followed, and Mrs. Potter also mentioned the open house following the dinner at the Municipal Center.

Mrs. Potter mentioned a serious accident this evening, and she explained that Greg's Towing assisted in doing a nice job of cleaning up the accident <u>scene</u>.

Mrs. Potter spoke with Senator Paul Pinsky at the Arbor Day celebration, and Senator Pinsky was responsible for helping to get the bill that required the Washington Suburban Sanitary Commission to notify the municipalities about when they planned to do their roadwork. This legislation originated out of the Four Cities Meeting.

Mrs. Potter commented on the amount of her water bill, and she stated that there was a drastic difference in the bill. A discussion followed.

Mrs. Potter commended Lt. Calhoon, and she felt that he and his officers were very responsive in making a difference in the safety of Carrollton Mall. Mrs. Potter stated that she wanted to express her thanks to them for this.

Council Member Fippin spoke briefly about the up-coming fundraiser for the Vera Cope Weinbach Scholarship Committee, and he explained that the proceeds would be used for three scholarships for youth planning to attend college.

Mr. Fippin urged all registered voters in the City to come out and vote on May 3, because this was a good way for the City to hear about what is needed.

Council Member Fippin mentioned that the Suburban Lions' Club was in favor of having a club in New Carrollton, and he briefly listed some of their activities and services. The club meets twice a month at the Langway's Restaurant on Route 450 in Lanham, and Mr. Fippin explained that interested residents might call the Municipal Center for additional information.

Chairman Garvey spoke about the Washington Suburban Sanitary Commission, and he mentioned that he has been having problems with his bill for years. Mr. Garvey felt that something must be wrong with their billing system, because his bill has been fluctuating This should not be happening when there are only two people living in the home. Council Member Schaffer explained that the if more water is used, then there would be a higher rate charged for the entire amount. Mr. Garvey stated that he was well aware of that; however, he also requested that a representative from Washington Suburban Sanitary Commission be invited to a Council workshop sometime after the election.

The Chairman explained that he was unable to attend the Garden Club's celebration, and he mentioned that he had attended their 35th anniversary. Mr. Garvey stated that this event was fantastic, and he knew quite a few of the members of the club from the house judging contest at Christmas time.

Chairman Garvey mentioned that the spaghetti dinner was the social event of the year, and it was an opportunity to meet everybody in town. This would also be an opportunity to visit the newly carpeted, painted, and tiled Municipal Center to see how your tax dollars are spent.

Chairman Garvey explained that the April 28th meeting regarding the police had been cancelled; however, there would be an article explaining the ballot question in the upcoming City Newsletter.

7. ADDITIONS TO THE AGENDA BY THE COUNCIL.

There were no additions tonight.

8. SUSPENSION OF THE RULES IN ORDER TO HEAR FROM CITIZENS-10 MINUTE LIMIT.

A. AUDIENCE PARTICIPATION.

A resident from 6108 85th Place came to the podium, and he invited everyone to attend the spaghetti dinner. A good turnout would help the fund, and the resident urged residents to return to the Municipal Center nine days later to vote. The resident stated that although he was always grateful for the people who do vote, only 10% of the registered voters actually come out and do so. There is a very important question regarding the police on the ballot this year, and the outcome of the election could have a drastic impact on the tax bills. Chairman Garvey thanked the resident for his comments tonight.

B. TELEPHONE PARTICIPATION.

A resident from 7401 Potomac Court telephoned to speak about the Washington Suburban Sanitary Commission bills, and she explained that her bill was not higher during the summer because she saved rinse water from the laundry to water the plants and lawn. The resident stated that she planned to be at the spaghetti dinner, and the Chairman thanked her for her comments tonight.

9. UNFINISHED BUSINESS.

Item No. 0399-01 Proposed Budget Amendment-Chapter CE-99 (Current Expense Budget for F.Y. 1999) Amendment No. 10.

Council Member Fippin explained that the Council had been having problems with this budget amendment, and they had discussed it with Diane Mock, the City Accountant. This amendment was very confusing and somewhat convoluted, and Mr. Fippin moved that it be removed from the table. Council Member Potter seconded the motion, and it was unanimously (5-0) approved as removed from the table. Mr. Fippin explained that the Council would be adopting a new Budget Amendment No. 16; therefore, he moved that no action be taken on this amendment. Council Member Potter seconded the motion, and it was unanimously (5-0) approved as dropped.

Item No. 0299-02 Proposed Budget Amendment-Chapter CE-99 (Current Expense Budget for F.Y. 1999) Amendment No. 11.

Council Member Fippin explained that this amendment concerned the undesignated fund balance, and the Council had been working with Diane Mock on it. Mr. Fippin then moved that the amendment be removed from the table. Council Member Hurdle seconded the motion, and it was unanimously (5-0) approved as removed from the table. Mr. Fippin then moved that no action be taken on this item. Council Member Potter seconded the motion, and it was unanimously (5-0) approved as dropped.

Item No. 0499-01 Proposed Budget Amendment-Chapter CE-99 (Current Expense Budget for F.Y. 1999) Amendment No. 14.

Council Member Schaffer explained that this item was currently on the table; therefore, he moved that it be removed from the table. Council Member Hurdle seconded the motion, and it was unanimously (5-0) approved as removed from the table. Mr. Schaffer explained that this amendment had been read once before at the last Council meeting, and it was for an estimated line item used to pay for five vehicles and an air compressor for the Department of Public Works. The loan would be paid back over a three and a half year period. Mr. Schaffer then moved that the item be approved. Council Member Hurdle seconded the motion, and it was unanimously (5-0) approved.

Item No. 0499-02 Proposed Ordinance No. 99-03 to Enact a New Chapter 10 of the <u>Code of Ordinances of the City of New Carrollton, Maryland, 1997 Edition</u>, Entitled "Emergency Preparedness Plan" for the Purpose of Laying the Groundwork for a Coordinated Response to a Wide Range of Situations Which Represent Significant Risk to Property, Severe Impacts to the Environment, and Most Importantly, Hazards to Human Health Or Life.

Council Member Potter explained that this item was currently on the table, and a copy of the document had been sent to the Prince George's County Fire Department, Office of Emergency Preparedness. The Council just received two suggestions made by the Office of Emergency Preparedness, and the item would need to be discussed more at the next workshop. Therefore, Mrs. Potter moved that the item remain on the table in order to give the Council more time to discuss it. Council Member Schaffer seconded the motion, and it was unanimously approved (5-0) as tabled.

10. NEW BUSINESS.

Item No. 0499-09 Introduction of Proposed F.Y. 2000 City Budget.

Council Member Schaffer introduced the budget for F. Y. 2000 by reading the budget ordinance as a "kick-off" for the Council's budget deliberations. Mr. Schaffer then moved that the item be tabled. Council Member Potter seconded the motion, and it was unanimously approved (5-0) as tabled.

Item No. 0499-10 Proposed Letter in Favor of Expanding County Pit Bull Restrictions to Include Rottweilers.

Council Member Hurdle explained that she had brought this to the attention of the Chairman and the Council because of a recent incident involving a Rottweiler. Mrs. Hurdle stated that there would be an article in the Newsletter regarding the City and County leash laws for animals in the City. Mrs. Hurdle further explained about the incident, and she stated that a resident walking his small dog on a leash was met by a Rottweiler that had escaped from its fenced yard. The Rottweiler repeatedly bit the smaller dog, and it was necessary to take the dog to the vet for treatment. The police were called, and the owner of the Rottweiler offered to pay the vet bills.

Mrs. Hurdle went on to explain some of the history behind the pending legislation; and she stated that after a huge debate, it was decided to remove Rottweilers from the list of dogs that are dangerous and bite. Mrs. Hurdle stated that the Council had received statistics today regarding the number of pit bull bites to humans – many were children; and this information should be included with the letter to County Councilman Thomas Hendershot, along with the Rottweiler statistics, in support of the legislation. Mrs. Hurdle then read the letter; and she moved that the letter, along with the two lists of statistics, be sent as soon as possible.

Chairman Garvey suggested that the following sentence be added to the second paragraph, "Also included you will find statistics regarding pit bulls." An "s" would be

added to the word "Enclosure" at the end of the letter, indicating both lists were attached. Council Member Hurdle agreed with Mr. Garvey, and Council Member Potter seconded the motion. Council Member Schaffer explained that some of his friends were opposed to this legislation; however, Mr. Schaffer planned to vote for the approval of the letter tonight.

Council Member Schaffer stated that he felt that the City might have a raccoon problem, because he had seen many such animals recently. Council Member Hurdle explained that Deputy Chief Taylor recommended to her that the residents might put rags soaked in household ammonia in the area around the trash receptacles in order to deter the raccoons. This remedy was not recommended for those with small children or pets. The Chairman called for the vote, and the motion was unanimously approved (5-0).

Item No. 0499-11 Rescinding of Budget Amendment No. 6-Chapter CE-99 (Current Expense Budget for F.Y. 1999).

Council Member Fippin explained that this amendment was passed in December, and there were problems regarding the undesignated fund balance. Therefore, Mr. Fippin moved that the amendment be rescinded. Council Member Potter seconded the motion, and it was unanimously (5-0) approved as rescinded.

Item No. 0499-12 Rescinding of Budget Amendment No. 7-Chapter CE-99 (Current Expense Budget for F.Y. 1999).

Council Member Fippiin explained that there would be further clarification on this item in Budget Amendment No. 16, later on in this meeting. Therefore, he moved that Budget Amendment No. 7 be rescinded. Council Member Hurdle seconded the motion, and it was unanimously approved (5-0) as rescinded. Chairman Garvey stated that there would need to be something signed by the Chairman and approved by the Mayor in order to rescind these amendments. Otherwise, there would not be a proper audit trail.

Item No. 0499-13 Proposed Budget Amendment-Chapter CE-99 (Current Expense Budget for F.Y. 1999) Amendment No. 15.

Council Member Potter explained this housekeeping amendment; and she stated that it would add funds for postage and telephone expenses for the Department of Public Works, <u>along with other items which she read into the record.</u> Mrs. Potter moved that the item be tabled, and Council Member Hurdle seconded the motion. The Chairman called for the vote, and it was unanimously approved (5-0) as tabled.

Item No. 0499-14 Proposed Budget Amendment-Chapter CE-99 (Current Expense Budget for F.Y. 1999) Amendment No. 16.

Council Member Fippin read this amendment regarding the undesignated fund balance and increasing the amount in street-lighting, street repair, roads, training, and Community Day programs. Mr. Fippin explained that the City's operating reserve contingency fund would also be increased, and he then moved that the item be tabled for further discussion. Council Member Hurdle seconded the motion, and it was unanimously approved (5-0) as tabled.

Item No. 0499-15 Request for Extension of Time Before Towing Vehicle of Fatu Ghedema, 6622 Adrian Street.

Council Member Hurdle moved that this request be granted for 30 days until May 21st. The vehicle was stored in the driveway, and there were expired temporary tags and no current registration. Council Member Potter seconded the motion, and it was unanimously approved (5-0).

11. SUSPENSION OF THE RULES IN ORDER TO HEAR FROM CITIZENS-10 MINUTE LIMIT.

A. AUDIENCE PARTICIPATION.

There was no audience participation at this time.

B. TELEPHONE PARTICIPATION.

There were no telephone calls at this time.

Chairman Garvey stated that it was good to see a full camera crew back tonight; although the short crew did an outstanding job at the last Council meeting. Mr. Garvey commented to Mr. Callimahos and his camera crew that he liked the way the telephone number for the Municipal Center overlapped the live broadcast simultaneously during this segment of the meeting.

12. ADJOURNMENT.

Council Member Fippin moved that the Council meeting be adjourned. Council Member Potter seconded the motion, and the meeting was unanimously (5-0) adjourned.

At this time, Chairman Garvey took the opportunity to thank everyone for watching tonight and for coming to the meeting.
