## MINUTES OF CITY COUNCIL MEETING CITY OF NEW CARROLLTON FEBRUARY 17, 1999

The regularly scheduled meeting of the City Council of the City of New Carrollton was held in the New Carrollton Municipal Center on Wednesday, February 17, 1999.

The meeting was called to order by Chairman Raymond J. Garvey. Present were Council Members James H. Fippin, Rose M. Hurdle, Sarah C. Potter, and John A. Schaffer; Mayor Andrew C. Hanko, Administrative Officer Mark L. Latour, Public Works Director Richard L. Robbins, and Treasurer Duane Rosenberg.

#### 1. PLEDGE OF ALLEGIANCE.

Chairman Garvey announced that Junior Girl Scout Troop #1543 and Brownie Troop #1784 would lead the Pledge of Allegiance tonight. Afterwards the Scouts came to the podium and introduced themselves. Each of the girls then stated their favorite Girl Scout cookie; and their leader, Ms. Deana Delemater, explained that the cookies are now in. Booth sales would be held at the local grocery stores, banks, and Blockbuster stores, beginning March 4. Ms. Delemater stated that cookies might be ordered by calling Mrs. Cheryl Delemater at (301) 577-4181, or their other leader, Mrs. Agnes, at (301) 577-2024. Ms. Delemater closed by thanking everyone for supporting the local Girl Scouts. Chairman Garvey thanked the Scouts for their participation tonight, and he stated that the telephone numbers for ordering additional cookies would be shown on cable television Channel B-10.

## 2. **REPORT OF THE MAYOR.**

Mayor Hanko reported that he attended a meeting of the police today which included the City's three Contract Police Officers and their supervisor, Lt. Calhoun. They discussed their schedules, radar, and people who ignore stop signs throughout the City. Even though crime in the City is down, speeding and stop signs are still being ignored.

Mayor Hanko stated that the New Carrollton Men's Club is now in the process of reorganizing, and they are accepting new applications for membership. The Club is open to all, including all New Carrollton women over the age of 21. The next meeting will be held on March 12 at the Municipal Center. Additional information will be available in the April Newsletter.

Mayor Hanko reported that the City recently hosted a business meeting at Carrollton Mall to discuss security at the Mall. Major Hunt and Lt. Calhoun were there, and it was mentioned that the Mall is now secure. All residents are encouraged to visit the Mall, and the next meeting of the business community will be held in the Municipal Center on February 25 at 8:30 a.m. All business owners are invited to attend.

Council Member Hurdle mentioned a telephone call she received from a resident who reported observing one of the New Carrollton Contract Police Officers issuing citations. The officer was not displaying the magnetic sticker on his patrol car, which indicated that he was working as a City Contract Officer. The Mayor responded that he would remind the officers to display their stickers at all times while on duty.

#### 3. **REPORT OF THE TREASURER.**

Treasurer Rosenberg reported that there were 41 invoices, and they totaled \$25,384.06. Mr. Rosenberg had reviewed the invoices, and he recommended that they be approved for payment. Based on the recommendation of the Treasurer, Council Member Potter moved that the bills be paid; and a copy of the list attached to the minutes of this meeting. Council Member Schaffer seconded the motion, and it was unanimously approved (5-0).

## 4. CONSIDERATION OF MINUTES OF THE BEBRUARY 1, 1999, COUNCIL WORKSHOP MEETING.

Council Member Hurdle moved that the minutes be approved as presented. Council Member Potter seconded the motion, and it was unanimously approved (5-0).

# CONSIDERATION OF MINUTES OF THE FEBRUARY 3, 1999, COUNCIL MEETING.

Council Member Potter moved that the minutes be approved as presented. Council Member Hurdle seconded the motion, and it was unanimously approved (5-0).

## 5. **REPORTS OF THE COUNCIL.**

Council Member Schaffer began his report by responding to a statement made by a resident who spoke at the last Council. The resident stated that the New Carrollton pool is a private pool because you have to be a member to use it. Mr. Schaffer reported that he had asked the resident if he would be attending the meeting tonight, and the resident responded that he was not sure. Mr. Schaffer then continued to clarify the point, and he explained that public and private obviously have different meanings. Mr. Schaffer

stated that the New Carrollton pool is as public as the Holiday Health Spa, YMCA, or the Greenbelt swimming pools are public. All of those swimming pools have yearly fees, and in that sense the New Carrollton pool is public. If public and private means, "Does the government run the pool," then the pool is public. If other than the government runs the pool, then it is private. As far as Mr. Schaffer is concerned, membership to the New Carrollton pool is open to all residents in New Carrollton; and this has been said many times.

Mr. Schaffer checked into the fees of the swimming pools in the area, and he stated that the fees for the New Carrollton pool range from \$225 to \$396, depending on the size of the family. These are last year's rates. The fee for the pool at the YMCA in Silver Spring is \$670 plus an initiation fee of \$130. The fee for the swimming pool at the Bally's Health Club is \$440 yearly, and the fee for the Greenbelt swimming pool is \$440 for non-residents year round. The fee for the College Park swimming pool, which is not run by the City of College Park but by the Maryland-National Capital Park and Planning Commission, is \$225 per family. That pool is open from 11:30 a.m. to 6:00 p.m.

Mr. Schaffer continued by stating that the New Carrollton pool is open for a longer period of time, and one of the advantages is that you get to swim with your friends and neighbors. Mr. Schaffer stated that he even called the Prince George's Housing Authority to see if Section 8 money could be used to pay for a pool membership. The answer was a resounding "no." Mr. Schaffer summarized that it is simply a matter of paying your money, and you can get into the pool.

Mr. Schaffer reported that he also attended the meeting with the police today, and he explained that the Council is in the process of looking into whether the City should have its own police force or continue with the Contract Police Officers. Mr. Schaffer again commented on the meeting with the police today, and he stated that he felt that the fact that both Major Hunt and Lt. Calhoun attended the meeting is indicative of the fact that the Prince George's County Police are supportive of the work the three Contract Police Officers are doing for the City of New Carrollton. Mr. Schaffer pointed out that crime is down; and, of the last eight car thefts, four were a result of the keys being left in the car with the motor running.

Mr. Schaffer reported that there is a new law, which makes it a crime to leave keys in a vehicle with the motor running. There is a \$50 fine for this violation, and recently Cpl. Easter observed a resident doing this, and he was prepared to issue a citation. Mr. Schaffer summarized by asking that residents please use common sense about this.

Mr. Schaffer reported that three students from Parkdale High School were picked up last week by the police. The students were armed with screwdrivers and other tools and prepared to steal some cars. Mr. Schaffer asked the Contract Police Officers if they were in the City at least 90% of the time, and they responded that they were.

Council Member Schaffer spoke about a new program at Carrollton Elementary called "Drop (Everything) and Read," and he explained that Principal Gaines welcomes volunteers to assist with this program. The duration is 15 minutes, and Mr. Schaffer stated that approximately 40% of the students walk to school. Mr. Schaffer asked that the students read to him from a book that was probably first grade level. The students did very well, and Mr. Schaffer praised them for their good job. Mr. Schaffer passed along a tip for parents regarding praising children. According to Mr. Schaffer it is wrong to say "That is such a good picture, you are going to become another Rembrandt or another Chopin." That way if they do not become Rembrandt or Chopin, they will not feel they have become a failure. Instead, praise them for exactly what they have done which is what they need to build their self-esteem to go on and tackle bigger things in school.

Mr. Schaffer spoke about the meeting last evening with representatives from Washington Suburban Sanitary Commission. The Council is supporting the passing of a bill that would require that the WSSC people inform the City well ahead of time that they are going to cut one of the City streets. Hopefully, this will provide better cooperation.

Mr. Schaffer stated that he planned to go to Carrollton Elementary School next week to assist with the third graders, and he extended an invitation to those interested in volunteering to come to the school to participate in the "Drop and Read" program.

Council Member Hurdle reported that she attended another Postal Advisory Council Meeting; and at that time, she picked up a bulletin giving all of the rates, fees, and changes for 1999. Mrs. Hurdle passed this along to Administrative Officer Latour.

Mrs. Hurdle spoke about the "Watch Your Car" program, and she mentioned that this was written up in <u>The Washington Post</u>, Prince George's News section, today. Mrs. Hurdle read part of the article; and she left copies of a brochure, listing statistics and tips on how to keep your car from being stolen, with Mr. Latour. Cpl. Lewis of College Park told Mrs. Hurdle that if a group of residents in New Carrollton were interested, he would be happy to come to the Municipal Center to talk to the group and explain the program. Interested persons may inform Mr. Latour, and hopefully, 15 or 20 residents might be interested in participating in this worthwhile program.

Council Member Hurdle stated that there has been four attempted auto thefts in the neighborhood, which have occurred at approximately 11:30 p.m. Mrs. Hurdle stated that she felt that this is a serious thing, and she felt that this happened because the New Carrollton Contract Police Officers do not work those hours.

Mayor Hanko responded that he disagreed with Mrs. Hurdle, and that the Contract Officers do work those hours. The Mayor continued by saying that there are only three Contract Officers, and they cannot work 24 hours a day. Mrs. Hurdle then summarized by stating that that is why she felt the City needs round-the-clock protection.

Council Member Hurdle reported that she also attended the meeting at Antonio's today regarding safety at Carrollton Mall with Major Hunt and Lieutenant Calhoun.

Mrs. Hurdle spoke about an incident involving residents who took their grandchildren to Carrollton Elementary School this past weekend to play on the school grounds. The residents observed debris there, and were concerned about the safety of their grandchildren because of this. Mrs. Hurdle reported that the residents telephoned her, and they stated that they planned to return to the school grounds to pick up some of the debris.

Mayor Hanko responded that a telephone call should be made to the School Board Member in order to get the problem resolved. County Councilman Hendershot may also be of assistance, and Mrs. Hurdle stated that the resident planned to talk to the Principal of Carrollton Elementary School about the problem. Mrs. Hurdle thanked the residents for their help in this matter.

Council Member Hurdle further discussed the Council's plan to put a question on the ballot regarding a police department for the City. Mrs. Hurdle explained that she was in Annapolis today; and while there, she spoke with Senator Leo Green's son, Leo Green, Jr. Mr. Green, Jr. stated that at the time a similar question was put on the ballot for the Bowie residents to vote on regarding having their own police department, the formula for tax differential was being put together and was not included in the question. According to Mr. Green, Jr. this is probably the main reason why the question failed. Mrs. Hurdle stated that she was sure Chairman Garvey would have all of the figures for the residents of New Carrollton in time for the ballot question. Mrs. Hurdle reported that she has heard from many residents who would be willing to pay for additional police protection.

Mrs. Hurdle explained that she was told by Mr. Leo Green, Jr. that the Council could contact Senator Pinsky, who would assist with having the fiscal service department contact Mr. Latour to work on the tax differential. It is also necessary to work with Prince George's County, and there is not much time for this.

Council Member Hurdle reminded residents that the cash register tapes for education program would be closing in the Giant stores on Saturday, February 27. Mrs. Hurdle called Safeway stores, and their closing date is February 28, and she urged residents to take all cash register receipts from those stores to your local school to help with the purchase of educational materials.

Council Member Hurdle reported that there is a car on Jodie with expired tags, and a resident informed her that the car has been there for some time. The car has been stickered, and Mrs. Hurdle stated that this indicates it would be towed soon.

Mrs. Hurdle reported that she has observed cars going through the stop sign on Jodie Street without stopping, and she hopes no one will be hurt up there.

Mrs. Hurdle suggested that the No Loitering signs should be posted in the area of the bridge at Carrollton Parkway and Lamont Drive, because she has observed children loitering there and playing in the street.

Council Member Potter mentioned Mrs. Thelma McDaniel, the City's long time Senior Citizens' Aid at City Hall, who passed away on February 3. Mrs. McDaniel was 84 years old, and Mrs. Potter stated that she knew and worked with her grandchild, Mr. Cyrus McDaniel, in the Prince George's Little Theatre. Mrs. Potter spoke about a very touching, on-stage tribute to Mrs. McDaniel by her grandson, Cyrus; and she summarized that Mrs. McDaniel was a delightful lady.

Council Member Potter spoke about the Council Workshop Meeting, and she stated that representatives of the Washington Suburban Sanitary Commission gave a very good presentation about pipes, water mains, and what they do at the Commission. The Council made it clear to the representatives that it supports the legislation by Senator Pinsky and Delegate Healey. There are some wording changes that may be made, and she felt it was a good presentation.

Mrs. Potter commented on the business meeting with Major Hunt, who seems to have the City's best interest at heart. The merchants that she talked to after the meeting mentioned that they thought that things were getting better at the Mall. Hopefully, these meetings would continue to help.

Council Member Potter mentioned a report entitled Cost to Operate and Maintain City Equipment, and she stated that this document is available at the New Carrollton City Hall. Mrs. Potter spoke about the rolling fleet, and how so many things have changed since Mr. Robbins became the Public Works Director. The City is now saving money

instead of wasting money on the fleet, and the annual net savings on the City fleet after 1989 is \$21,506. For the past nine years, this amounts to a savings of \$193,522, which is phenomenal. Mrs. Potter then congratulated Mr. Robbins, and she asked him to explain about some of the recycling figures from Public Works. Mr. Robbins reported that there is a savings of between \$350,000 and \$400,000 in tipping fees, which is an example of how the City is trying to provide services for the residents and save money.

Chairman Garvey reported that the point was made at the last meeting that there was a conflict of interest if the City Council voted for the tax break for the New Carrollton pool. The City Attorney stated that if there was no financial gain accrued to the City Council Members for voting for the small tax credit for the swimming pool, then there was no conflict of interest. The Attorney further recommended that when matters come up in the future in which members of the public might worry about a conflict of interest, the Council Members might disclose this relationship. The Attorney also stated that this does not mean that a Council Member would not necessarily have to abstain from a vote. If there is a conflict of interest; and you publicize that there is a potential conflict of interest, you can still vote on the matter.

Chairman Garvey stated that the New Carrollton Neighborhood Watch committee would be meeting on March 6, at 10:00 a.m., in the multi-purpose room at the Municipal Center. One of the guest speakers will be Lt. Calhoun, the new supervisor of the City's Contract Police Officers. Cpl. Schultz, one of the Community Oriented Police officers, would also attend the meeting, and there would be refreshments.

The Chairman reported that he has been working on a question for the ballot in the May election for a police force at the request of his colleagues. Mr. Garvey explained that the Bowie study would be used as a grid, and this would be adapted to New Carrollton to come up with the necessary figures. Mr. Garvey handed out a very rough draft at the Council workshop meeting, and he stated that if there was trouble getting the figures, then maybe Senator Pinsky could be consulted.

Chairman Garvey spoke briefly about the problem of drivers not stopping at the stop sign on Jodie Street.

## 7. SUSPENSION OF THE RULES IN ORDER TO HEAR FROM CITIZENS - 10 MINUTE LIMIT.

## A. AUDIENCE PARTICIPATION

Mr. Lamont Bell, 8314 Stanwood Street, came to the podium, and he discussed his concern about a recent incident. Mr. Bell reported that there is a group coming into the neighborhood trying to steal bicycles, and he wished to warn the residents about this. Mr. Bell briefly discussed the problem of residents not turning on their porch lights, and he urged them to do this to brighten up the areas at night. Chairman Garvey thanked the resident for his participation tonight.

## **B. TELEPHONE PARTICIPATION.**

Mr. Dick Bechtold, 6462 Fairborn Terrace, telephoned to express his concern about the lack of towing requests at Greenbelt Road Shell station. Mr. Bechtold asked if the City is still towing cars, and Mr. Latour explained that the new part-time Code Enforcement officer has been on vacation for the past two weeks. Towing will resume shortly, according to Mr. Latour. Mr. Bechtold asked for the name of the back-up towing company, and Mr. Latour promised to call him with that information.

Mr. Bechtold reported an incident at Lamont Drive and Westbrook Parkway where he had observed a car running a stop sign; and he spoke about another incident when stop signs have been ignored. Mr. Bechtold summarized by stating the City vehicles and police officers must set a good example for residents by obeying the laws.

Mr. Bechtold asked about the new post office location, and Mrs. Hurdle stated that a decision would be made soon to approve a space at the Glenridge shopping center, adjacent to the Giant food store. Chairman Garvey thanked Mr. Bechtold for his comments tonight.

Mrs. Jenkins, 5402 85<sup>th</sup> Avenue, telephoned to express her concern about the problems she has been having with the Jones Communications system. Mrs. Jenkins reported a recent interruption in her cable service, and she asked if there is a chance that the City would get satellite television in the future. Chairman Garvey stated that Jones is ready to sell to Comcast; and, hopefully, the service will improve. Mr. Garvey stated that residents might get a refund on their bill if there is an interruption in service by calling Jones and informing them of this. The resident reported that she tried this, and the lines are frequently busy. Chairman Garvey reported that representatives of Comcast would be present at one of the up-coming Council meetings, and residents would have an opportunity to ask questions.

Mrs. Jenkins commented on the problem of the over-grown trees down by the subway station. Mr. Robbins reported that the trees in questions are just outside of the City limits; however, he contacted the County about this so that the problem would be resolved soon. Chairman Garvey thanked the resident for her comments tonight.

Mr. Nicholas Lozepone, 6106 85<sup>th</sup> Place, telephoned to express his concern about the City policy on the political sign on Riverdale Road and Route 450. Mayor Hanko responded that he would ask Carrollton Realty to take the sign down, and if this did not happen, then the City Department of Public Works would take it down. The Chairman thanked the resident for his comments tonight.

Mr. Bob McKinnon, 7406 Longbranch Drive, telephoned to express his concern about the possibility of the City having its own police department. In regard to Mr. Schaffer's comments regarding the visibility of the police, Mr. McKinnon reported that he does a lot of walking around the City. Mr. McKinnon stated that he has observed that the police are visible, and it gives him a good feeling to know that the police are there. Chairman Garvey thanked the resident for his comments tonight.

Then Council Member Potter would make a motion that this item be tabled, and the City Attorney would be present on March 3 for 100 public hearing. There would be a further explanation by the City Attorney at that time. The documents are very lengthy and technical, and they would be available at the Municipal Center if any residents wished to review them.

Council Member Potter explained that Attorney Manzi had prepared a summary, which reduced the thick volume with layman's terms, which was very helpful. There is also an index, and Mrs. Potter summarized that this agreement is comparable to the Fairfax and Montgomery County renewal contracts.

Mrs. Potter then discussed the three different parts of the renewal contract, and she began with the Ordinance No. 9901. Council Member Potter moved that this ordinance be Council Member Schaffer conded the motion, and it was unanimously tabled. approved (5-0) tabled.
