CITY OF NEW CARROLLTON MINUTES COUNCIL WORKSHOP MEETING MONDAY, APRIL 18, 2022

The Council Workshop Meeting was held at 7:07 p.m., on Monday, April 18th, 2022, as a virtual meeting. Attending was Chairperson Cynthia DB Mills; Councilmember Katrina R. Dodro; Councilmember Allyne Hooks; Councilmember Sarah Potter-Robbins; and Briana Urbina; Mayor Phelecia Nembhard; City Administrative Officer Latasha Gatling; City Clerk Robinson Brown; Assistant City Administrative Officer Michael McMahon; Chief David Rice; Director of Public Works Andre Triplett; Information Technology Administrator Andrew Facey; and Administrative Assistant Araceli Guzman.

1. CALL TO ORDER

Chairperson Mills welcomed everyone and called the meeting to order, wishing everyone a Happy Easter.

2. REPORT OF THE MAYOR AND ADMINISTRATION

Chief David Rice briefly discussed the laws that have changed in the last two years. He explained the county and state's new process for issuing an arrest. Chief Rice asked that if anyone had questions or concerns, please call or email him directly.

City Administrative Officer Gatling thanked everyone who attended the Spring Festival. She informed everyone that she, Mayor Nembhard, and Assistant CAO, Michael McMahon attended Prince George's County Public Hearing for the CDBG Action Plan. The city is slated to receive the grant that she had mentioned in the previous meeting. The contractors began the renovations in the bathrooms at the Municipal Center. Lastly, Ms. Gatling announced/introduced our new HR/Special Projects Assistant.

Director of Public Works Triplett was called on to give his report and began with a report on the Clean Water Partnership and Pedestrian Bridge, stating that the corrections are now complete and they are just waiting for the date of the Ribbon Cutting Ceremony to be announced. Pepco will be doing High Powerline tearing beginning this Spring. Eight trees will be removed and re-planted by Pepco. The Community Gardens are now opened and will be serviced weekly. Mr. Triplett invited everyone to attend the Arbor Day Tree Planting Ceremony at Sports Park on April 29th at 10 a.m.

Mayor Nembhard began her report by informing everyone of the calls she's been receiving regarding the cleanliness of the City of New Carrollton and the beautification of the flowers planted throughout the city. She thanked the Department Public Works for their hard work

and dedication. Mayor Nembhard stated that the Community Gardens is completely sold out. She also reminded everyone that the Green Team Community Cleanup was taking place on Saturday, April 23rd. Mayor Nembhard thanked everyone who helped and participated in the Spring Festival.

Chairperson Mills then asked the Council if they have questions or comments.

Chairperson Mills addressed the council requesting that no one respond to emails from residents unless it is shared with everyone. She then asked Chief a question pertaining to a misdemeanor and the 911 disconnect.

Councilmember Hooks asked Mr. Triplett if he knew when the wording on the signs at the bridge would be changed? Mr. Triplett replied, that they are currently working on the verbiage to be added to sign.
