Chairperson Mills called the Council meeting to order at 7:04 pm.

Councilmember Dodro thanked the resident who came out to do the meet and greet the past Saturday; Chairperson Mills stated that it is not a Council topic, she requested to mute Councilmember Dodro; Chairperson Mills stated that such meeting according to comments from city residents was a topic about campaigning and such topic is not to be discussed on a Council meeting.

Councilmember Lashley started by congratulating Governor-Elect Wes Moore, and Aruna Miller, Lieutenant Governor-Elect; he expressed his condolences to the passing of former Delegate Tawanna Gaines; he wished his colleagues, the Mayor and her staff and to the residents a happy Thanksgiving holiday; he reiterated about going forward on the following items: The
