Two parcels of land adjacent to Margaret Brent Regional Special Education Center and an additional parcel adjacent to Robert Frost Elementary School, at a price offer of "\$850,000.", or any new negotiated price for or all the parcels. These acquisitions would allow Prince George's County Public Schools to build two new replacement schools that would benefit the community.

Chairperson Mills moved that the City Council approve PGCPS to Purchase Land from the City of New Carrollton, the sale if for two parcels of land adjacent to Margaret Brent Regional Special Education Center, and an additional parcel adjacent to Robert Frost Elementary School, at a price offer of \$850, 000., for or all the parcels. These acquisitions would allow Prince George's County Public Schools to build two new replacement schools that would benefit the community.

Chairperson Mills called the motion. Councilmember Urbina seconded the motion. There was a discussion. Chairperson Mills called for the vote. The motion passed (5-0-0).
